KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 10th day of February 2006, Mark L. Adcock and Tiffany Rasband Adcock, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc, as nominee for First Franklin a Division of Nat. 
