Subject to mineral and mining rights if not owned by Grantor.

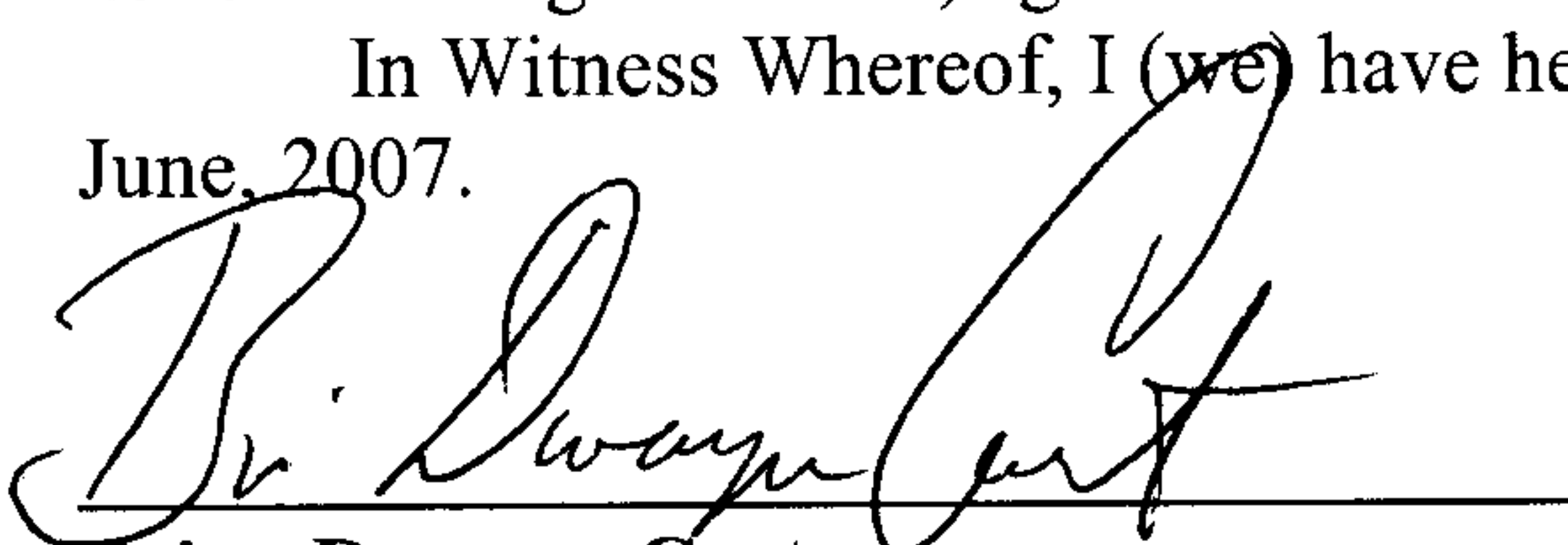
Subject to existing easements, restrictions, set-back lines, rights of way, limitations, if any of record.

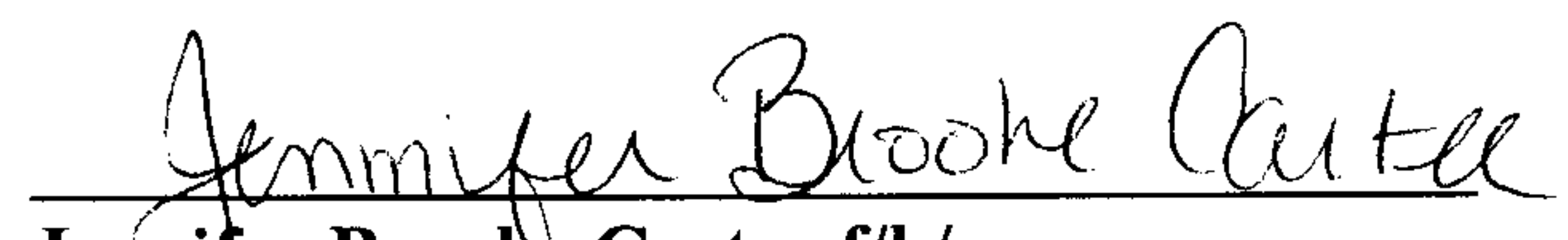
Jennifer Brooke Carter is one and the same person as Jennifer Brooke Colgalzier, grantee in deed recorded in Instrument No. 20040428000220170.

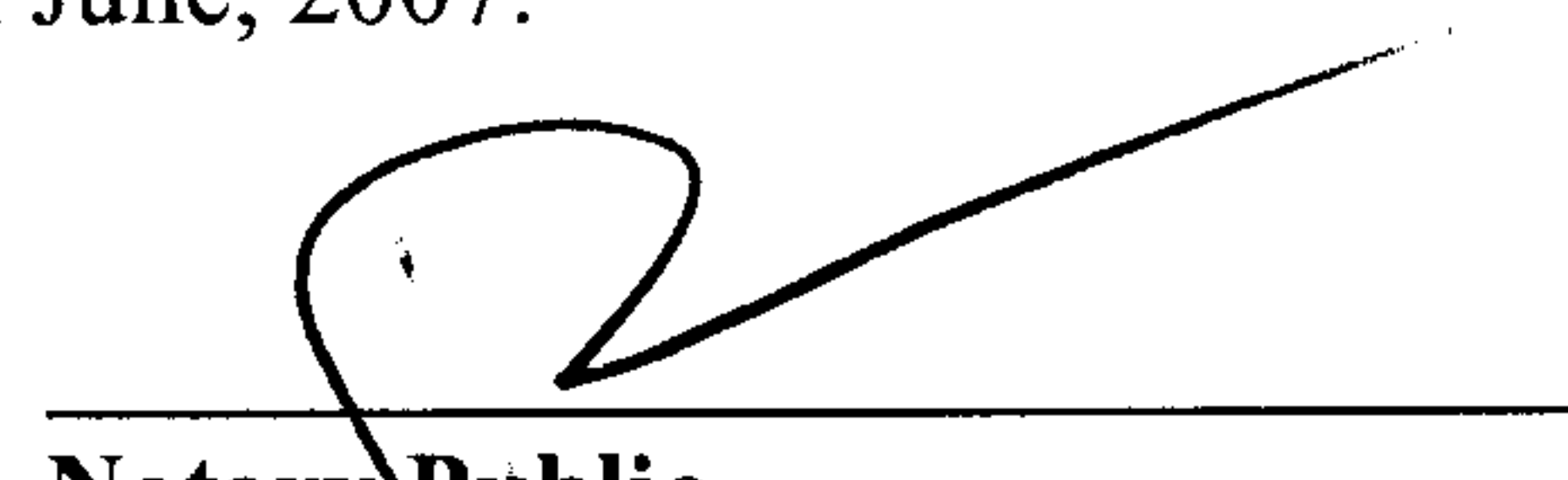
