Know All Men by These Presents: That in consideration of **Two hundred eleven thousand and no/100 (\$211,000.00)** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Mark S. Sims and Deborah B. Sims, husband and wife** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Robert A. Carter and Greta L. Carter** (herein referred to as grantee, whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:
