## **WARRANTY DEED**

**STATE OF ALABAMA**

**SHELBY COUNTY**

**KNOW ALL MEN BY THESE PRESENTS**, that in consideration of TEN AND NO/100 DOLLARS, to the undersigned grantor (whether one or more) in hand paid by the grantee herein, the receipt whereof is hereby acknowledged, I, **Susan Costen Crumpton, as Personal Representative of The Estate of Jean T. Flurry, deceased** (herein referred to as grantor, whether one or more), do grant, bargain, sell and convey unto **Susan Costen Crumpton, an unmarried woman**, (herein referred to as grantee) the following described real estate situated in Shelby County, Alabama, to-wit:

**All of the Southeast 1/4 of the Northwest 1/4 of Section 34, Township 19, Range 1 East except that part (being a small triangle) lying Southeast of Chelsea and Harpersville Road.
