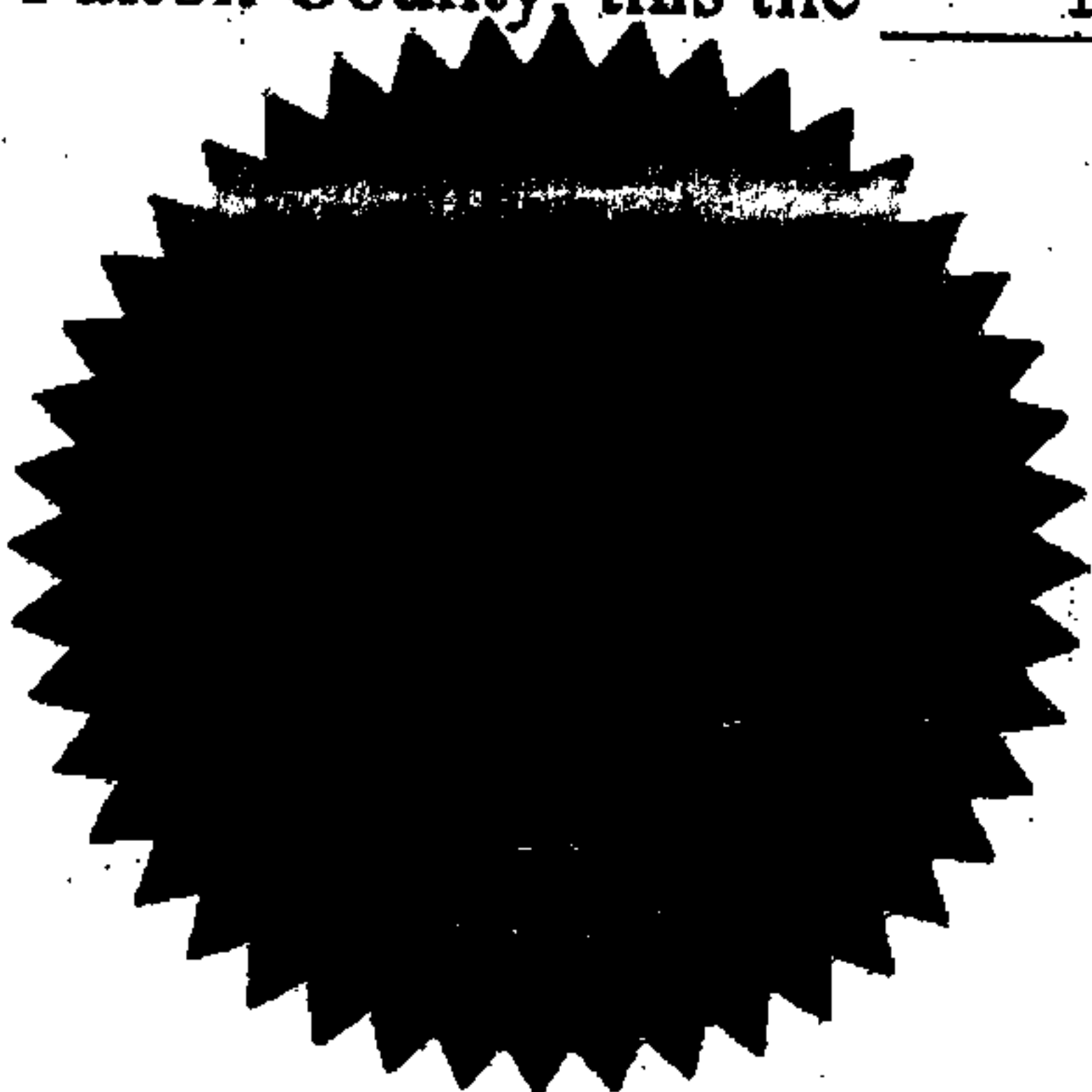

ORDER FOR JUDGMENT

Plaintiff's Motion to Strike Answer and for Entry of Judgment by Default has been filed for thirty (30) days and no response has been filed by Defendants. Plaintiff's attorney has provided this Court with a letter from Defendants' attorney advising that Defendants have "elected not to proceed with the defense of this case". Accordingly, Plaintiff's Motion is now ripe for ruling;

Based upon the review of the pleadings and record of this case, this Court finds that the Answer filed on behalf of Defendants in this action was not timely filed within thirty (30) days of the date of service and that Defendants have not moved the Court to open the default;

This Court further finds that the Answer filed on behalf of Defendants was filed by an individual unlicensed to practice law in the State of Georgia and, accordingly, said Answer is a nullity;

Based upon the foregoing, this Court hereby GRANTS Plaintiff's Motion to Strike Answer and enters judgment against Defendants, jointly and severally in the principal amount of \$105,173.63, plus interest through the date of judgment in the amount of \$22,086.45, plus reasonable attorney's fees pursuant to O.C.G.A. § 13-1-11 in the amount of \$12,277.73, plus post-judgment interest at the contract rate of one and one half (1.5%) percent per month from the date of judgment and all costs of this action.
