

ARTICLES OF INCORPORATION  
OF

DOMESTIC NON-PROFIT CORPORATION

ARTICLE I

The name of the corporation is Alaga Landing Homeowners Association, hereafter known as Alaga Homeowners Association or the "Association". The Association is a non-profit organization.

ARTICLE II

The duration of the corporation is perpetual.

ARTICLE III

The corporation has been organized to implement the powers given to it by the relevant portions of the Declaration of Covenants, Conditions, and Restrictions for Alaga Landing Subdivision.

ARTICLE IV

The members of the Association consist of all of the record Owners of lots within the plat of Alaga Landing, as recorded in the Office of the Judge of Probate of Chilton County, Alabama, in Plat Book 109 at Page 5, as well as the owners of other properties dedicated pursuant to the covenants, conditions and restrictions for Alaga Landing. The qualifications and rights of the members are set forth in the by-laws of Alaga Landing Homeowners Association.
