ARTICLES OF ORGANIZATION
OF
CLOUDSTAT L.L.C.

The UNDERSIGNED Organizer desires to form a limited liability company pursuant to the provisions of the "Alabama Limited Liability Company Act" as codified in Chapter 12 of Title 10 of the Code of Alabama of 1975, as amended (the "Act"), and does hereby adopt the following Articles of Organization:

ARTICLE ONE

NAME OF THE COMPANY

The name of the limited liability company is CloudStat L.L.C. (the "Company").

ARTICLE TWO

DURATION

The duration of the Company shall be perpetual, and the Company shall continue until it is dissolved in accordance with the provisions of the Act.

ARTICLE THREE

PURPOSE

The purpose for which the Company has been organized is the transaction of any and all lawful business for which a limited liability company may be organized under the Act, including, but not limited to, the following:

1. To buy, sell, invest in, manage, encumber, hypothecate, pledge, mortgage, and otherwise deal in and with stocks, bonds (and other evidences of indebtedness), securities, options to purchase or sell any of the foregoing, real estate, interests in limited partnerships, limited liability companies, and other business entities, and such other investments, property and assets as the members of the Company shall determine.

2. To accomplish any lawful business whatsoever or which shall at any time appear conducive or expedient for the protection or benefit of the Company and its property.
3. To exercise all other powers necessary to or reasonably connected with the Company's business which may be legally exercised by limited liability companies under the Act or under the laws of any jurisdiction in which the Company may conduct its business.
4. To engage in all activities necessary, customary, convenient, or incident to any of the foregoing.

ARTICLE FOUR

The member(s) of the Company shall have the right to admit additional members as provided in the operating agreement entered into between the members pursuant to Section 10-12-24 of the Act.

ARTICLE EIGHT

PROVISIONS OF THE OPERATING AGREEMENT

Any provision that is not inconsistent with the law for the regulation of the internal affairs of the Company is permitted to be set forth in the operating agreement of the Company.
