THIS FORECLOSURE DEED made this 3rd day of July, 2007, between KIMBERLY M. GLENN and BRIAN G. GLENN, wife and husband, Party of the First Part, and BANKFIRST, A STATE CHARTERED BANK, Party of the Second Part;

WITNESSETH:

WHEREAS, the said KIMBERLY M. GLENN and BRIAN G. GLENN, wife and husband, heretofore executed to MORTGAGE ELECTRONIC REGISTRATION SYSTEMS, INC. 
