- 1. That she is over the age of eighteen years and makes this Affidavit on her own personal knowledge and belief.
- 2. That John Wesley Boyce, Sr., as Grantor, and John Wesley Boyce, Sr. and Mayron B. Boyce, as Trustee, entered into a Trust Agreement dated July 8, 1994, hereinafter called "Trust Agreement".

- 4. That the Grantor, John Wesley Boyce, Sr., is unable to manage the financial affairs of the Trust. Two qualified physicians, Jane Pearson, M.D. and Barry McLean, M.D., Ph.D., have stated in letters (copies of said letters are attached hereto and made a part hereof as Schedule "A") that John Wesley Boyce, Sr. is unable to handle his own business affairs.
- 5. That as a result of John Wesley Boyce, Sr.'s incapacity, Mayron B. Boyce will serve as Trustee under the terms of the Trust Agreement.


