GENERAL WARRANTY DEED

Devlin, an unmarried man,** (hereinafter referred to as Grantor), the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the Grantee, **Lynn Schoener**, (hereinafter referred to as Grantee), in fee simple, together with every contingent remainder and right of reversion, their heirs and assigns, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

Lot 19, according to the Survey of Valleybrook, Phase II, a resurvey as recorded in Map Book 12, Page 12, in the Office of the Judge of Probate of Shelby County, Alabama; being situated in Shelby County, Alabama. Mineral and mining rights excepted.

SUBJECT TO:

- 1. Ad valorem taxes due and payable October 1, 2007.
- 2. All restrictions, easements, Rights of parties in possession, encroachments, liens for services, labor, or materials, taxes or special assessments, building lines.

- 5. Matters which would be revealed by a survey of the property conveyed.

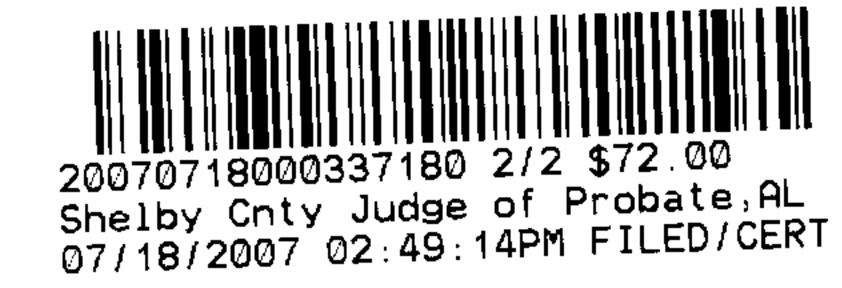
(\$232,000.00 of the purchase price was paid from a mortgage loan closed simultaneously with delivery of this deed.)
