ARTICLE III

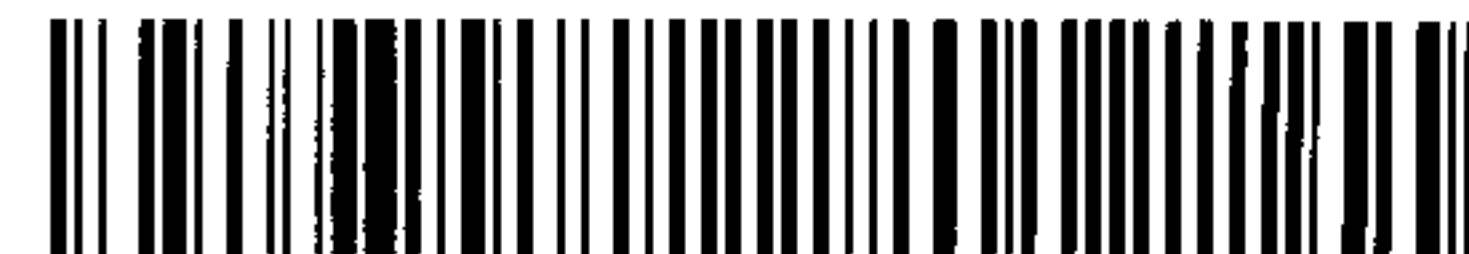
PURPOSES
