

ARTICLES OF ORGANIZATION
OF
FOREST GROWTH & INCOME, L.L.C.

Pursuant to the provisions of the Alabama Limited Liability Company Act, §10-12-1 et seq., Code of Alabama, 1975 (the “Act”), the undersigned hereby adopts the following Limited Liability Company Articles of Organization.

ARTICLE I.

Name

The name of the limited liability company is Forest Growth & Income, L.L.C. (the “Company”).

ARTICLE II.

Duration

Pursuant to §10-12-4 of the Code of Alabama (1975), the Company shall have perpetual duration, unless it is dissolved and its affairs wound up in accordance with the Act, or as provided in the Company’s Operating Agreement.

ARTICLE III.

Purposes

The purposes for which the Company is formed are:

- (a) To engage in the business of providing forestry services, including services related to timber production and forestry economics and marketing;
- (b) To engage in any industrial, manufacturing, mining, mercantile, trading, agricultural, service, or other lawful business of any kind or character whatsoever;
- (c) To act as agent, representative, or receiver of any person, firm, corporation, or governmental entity or instrumentality in respect to any lawful undertaking or transaction;
- (d) To purchase, take, receive, lease or otherwise acquire, own, hold, improve, use, and otherwise deal in or with, real or personal property, or any interest therein, wherever situated, and to sell,

convey, mortgage, pledge, lease, exchange, transfer and otherwise dispose of real or personal property, or any interest therein;

(e) To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, corporations, limited liability companies, associations, partnerships, individuals, or direct or indirect obligations of governmental entities or of any instrumentality thereof;

(f) To lend money, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested; and

(g) To engage in any other lawful act or activity for which limited liability companies may be organized pursuant to the Act.

ARTICLE IV.

Registered Agent; Registered Office

The location and street address of the initial registered office shall be Forest Growth & Income, L.L.C., 206 Cahaba Lake Circle, Helena, Alabama, 35080, and its registered agent at such address shall be Fredrick C. Nelms.

ARTICLE V.

Initial Member and Organizer
