Pelham, AL 35124, which is the address of the Grantees.

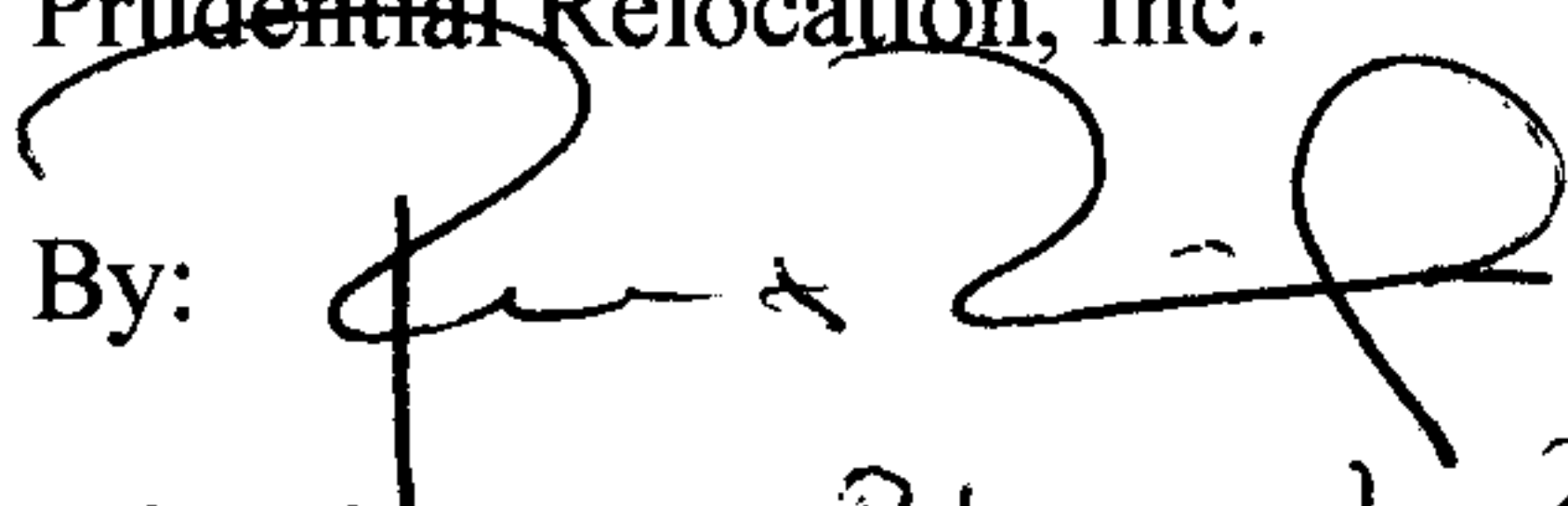

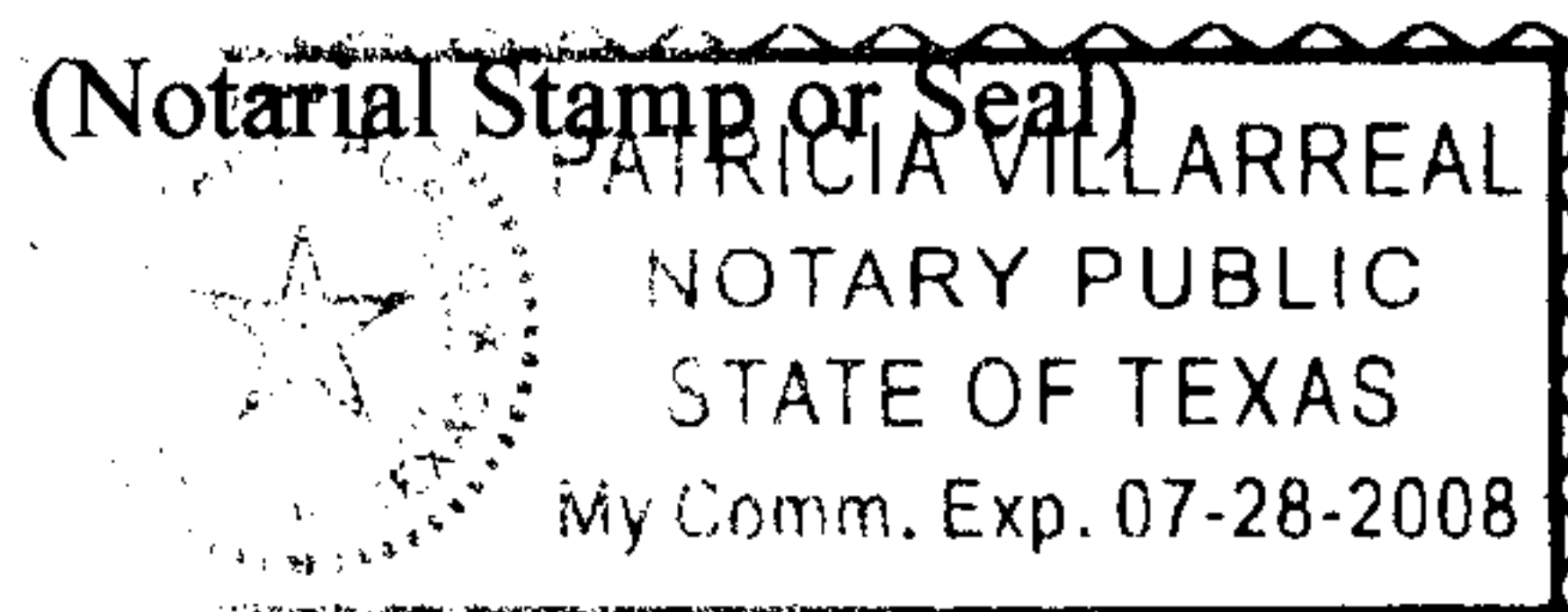

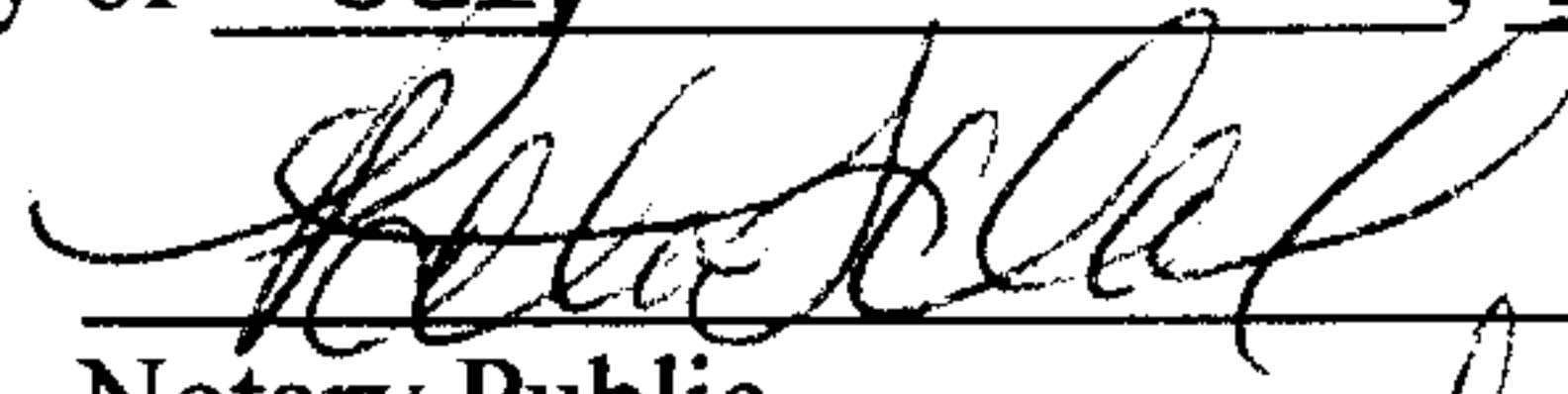
