ARTICLES OF ORGANIZATION

OF

TO THE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA:

The name of the limited liability company ("Company") is WISTERIA DEVELOPMENT COMPANY, LLC:


ARTICLE II

PURPOSES


The Company has been organized for the following purposes:


