WITNESSETH:

WHEREAS, **Kimberly-Clark Corporation**, a Delaware corporation, as Lessor, and **CDX Sequoya, LLC**, a Texas limited liability company, **CDX Gas, LLC**, formerly a Texas liability company, now reorganized as a Delaware limited liability company, and **CD Exploration, Inc.**, an Oklahoma corporation (collectively referred to herein as "Lessee") entered into an unrecorded Coalbed Methane Gas Lease ("Said Lease") dated November 29, 2004 (The "Effective Date") wherein Lessee leased certain interests in Bibb and Shelby Counties, Alabama, which Said Lease is evidenced by Memorandum of Coalbed Methane Gas Lease recorded in RPB 148, page 508 in the Deed Records of the Judge of Probate of Bibb County, Alabama on March 3, 2005 and as Instrument No. 20050303000100950 in the Deed Records of the Judge of Probate of Shelby County, Alabama on March 3, 2005; and

WHEREAS, said Lease was amended by a First Amendment to Coalbed Methane Gas Lease, as filed in the Office of the Probate Judge of Bibb County, Alabama in Real Property Book 182, at Page 201, and in the Office of the Probate Judge of Shelby County, Alabama as Document No. 20061201000585020, to which reference is here made for all purposes; and

WHEREAS, said Lease, as amended, was ratified by **Kimberly-Clark Worldwide, Inc.**, a Delaware corporation, in that certain Ratification of Coalbed Methane Gas Lease, as filed in the Office of the Probate Judge of Bibb County, Alabama in Real Property Book 190, at page 186, and in the Office of the Probate Judge of Shelby County, Alabama as Document No. 20070410000163750, to which reference is here made for all purposes; and

WHEREAS, the parties now desire to amend said Memorandum of Coalbed Methane Gas Lease to recognize that certain language was added to amend Article 3.10 and Article 2.1 of Said Lease;

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS, **Kimberly-Clark Worldwide, Inc.** and Lessee, for and in consideration of the mutual benefits to be derived by the parties hereto, do hereby amend said Memorandum of Coalbed Methane Gas Lease to recognize that certain language was added to amend Article 3.10 and Article 2.1 of the above referenced unrecorded Lease.

IN WITNESS WHEREOF, the parties hereto have duly signed this Memorandum of Second Amendment to Coalbed Methane Gas Lease on the 9th day of July, 2007, to be effective as of the 29th day of November, 2004, for the sole purpose of giving record notice of the executed Second Amendment to Coalbed Methane Gas Lease and the existence thereof.
