\$352,000.00 and \$66,000.00 of the above consideration was paid from the proceeds of that mortgage closed simultaneously herewith.

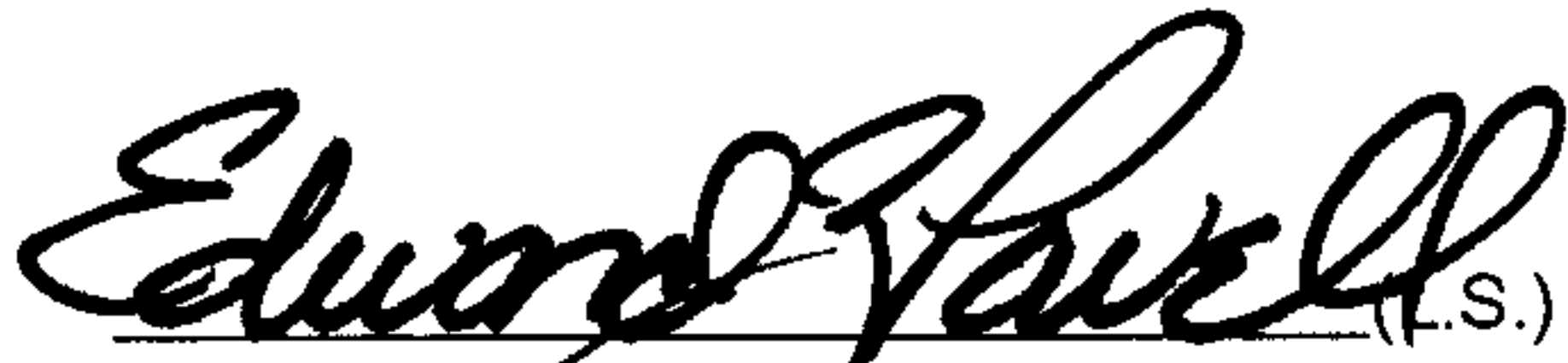

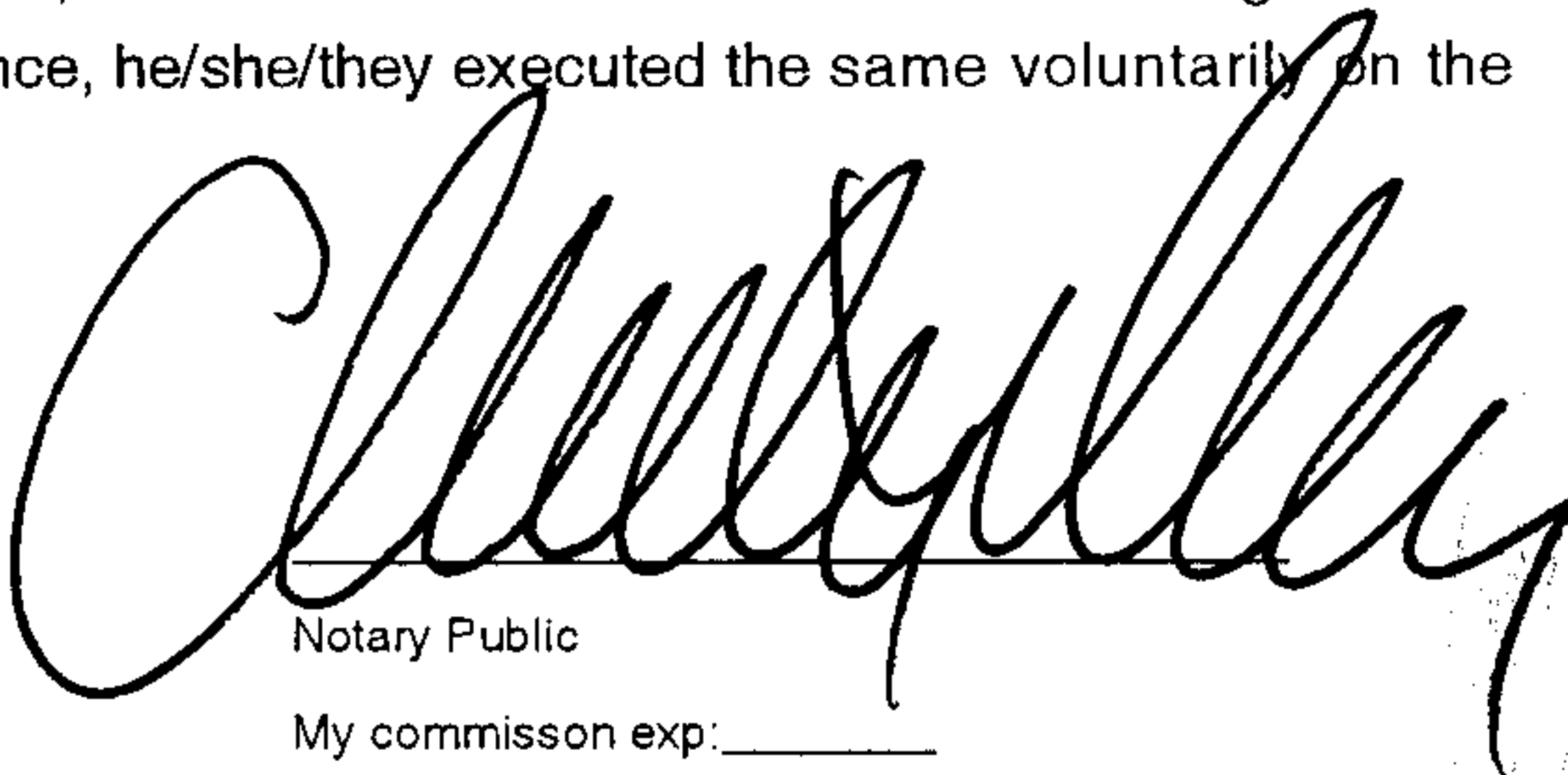
