ARTICLE III

PURPOSE

The nature of the business of the Company and its objects, purpose and powers are and shall be to operate a Granite installation for the sale of Granite for profit, income, and appreciation, and to conduct or do any other lawful act or business permitted of the company under the Alabama Limited Company Act.

ARTICLE VIII

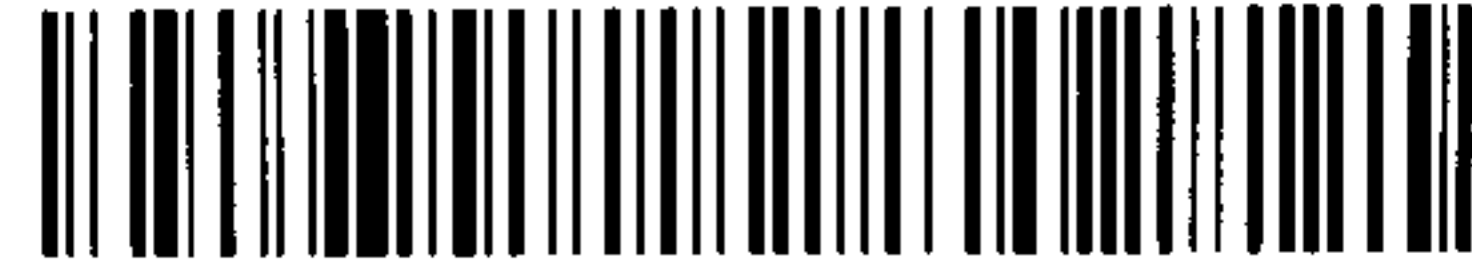
MANAGEMENT
