

KNOW ALL MEN BY THESE PRESENTS, That whereas heretofore on to-wit: the 28th day of February, 2003, Nickolas Gulas and Teshia Gulas, husband and wife, executed a certain mortgage on the property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee NetBank f/k/a RBMG, Inc., as recorded in Instrument No. 20030415000228930 in the Probate Office of Shelby County, Alabama.
