## WARRANTY DEED

STATE OF ALABAMA )

SHELBY COUNTY )

KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of **One Hundred Seventy Seven Thousand Five Hundred dollars and Zero cents ( \$177,500.00 )** paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, **Sean Steven Whilden and Ellen Alexander Whilden, husband and wife** (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto **Derrell W. Billingsley and Jana Billingsley, as joint tenants with rights of survivorship** (hereinafter Grantees), all of my/our right, title and interest in the following described real estate, situated in **Shelby County, Alabama**:

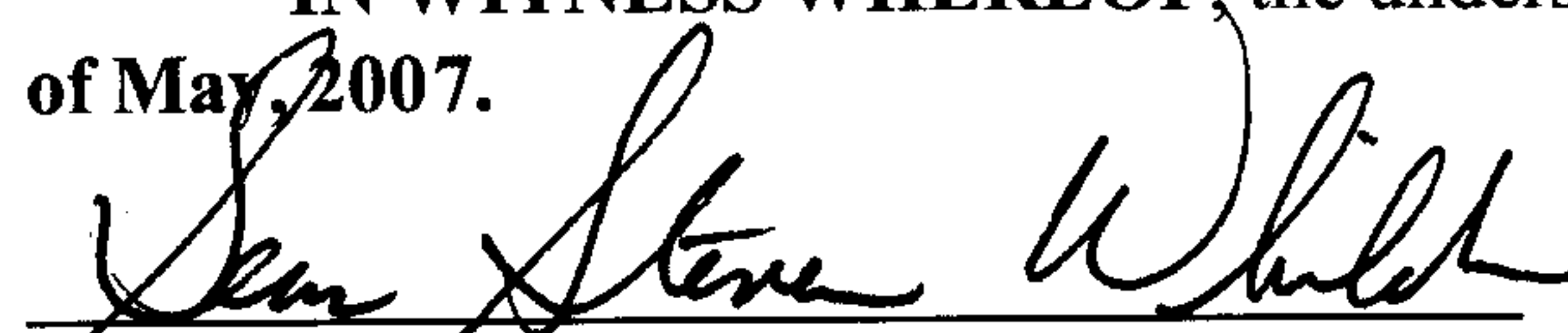
Subject to current taxes, all matters of public record, including, but not limited to easements, restrictions of record, and other matters which may be viewed by observation.

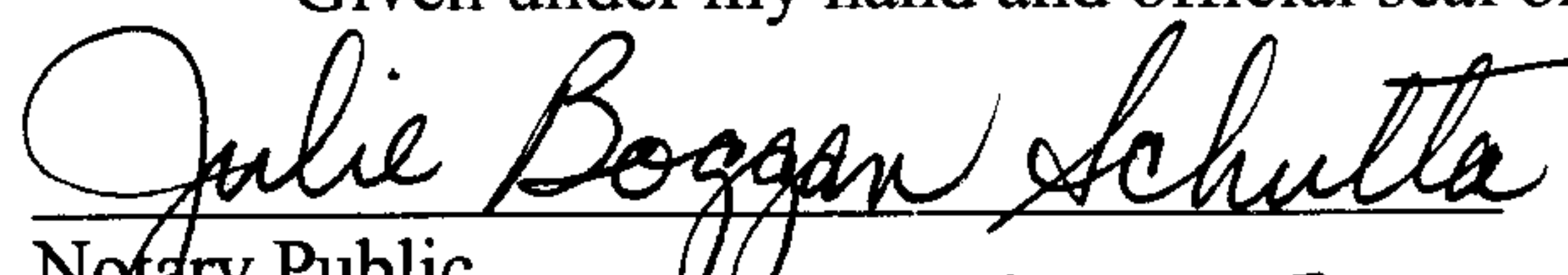
