

**AMENDMENT TO CERTIFICATE AND AGREEMENT
OF LIMITED PARTNERSHIP OF
FS INVESTMENTS, LTD.**

1.4 **Partners' Names and Mailing Addresses.** The name and mailing address of the general partner is set forth in section 4.1. The name and address of the limited partner is Buck, LTD., 2108 Swan Lake Cove, Birmingham, Alabama 35244.

4.1 **General Partner.** Buck, LTD., is hereby named the general partner of the limited partnership and its address shall be 2108 Swan Lake Cove, Birmingham, Alabama 35244.

4.2 **Limited Partner.** Buck, LTD., is hereby named the sole limited partner of the limited partnership and has contributed in cash to the capitol of the limited partnership the amount set forth in section five of the Certificate and Agreement of Limited Partnership. The mailing address of the limited partner, Buck, LTD., is 2108 Swan Lake Cove, Birmingham, Alabama 35244.

5.1 **Profits and Losses Distributions.** Of profits and losses derived from the limited partnership and each item of income gained, loss, deduction and credit entering into the computation thereof, shall be allocated to the general partner and limited partner as follows:
