CORPORATION ACT, THE UNDERSIGNED HEREBY ADOPTS THE
FOLLOWING ARTICLES OF INCORPORATION.**

Article I The name of the corporation:

Article II The duration of the corporation is "perpetual".

Article III The corporation has been organized for the following purposes:

To own, operate, conduct and manage a facility for the purpose of operating as a contractor with Federal Express Corporation to provide van(s) and to deliver packages on a daily basis, Tuesday thru Saturday, or as otherwise stated in any contract between Federal Express Corporation and GET TO THE LAKE, INC.

To purchase or otherwise acquire, own, pledge, sell, assign and transfer or otherwise dispose of, and invest, trade and deal in and with goods, wares and merchandise of every class and description, whether or not the same specifically pertain to the classes of business above specified; and to do all things necessary, suitable and proper for the accomplishment of the aforesaid purposes, either alone or on behalf of or in association with other corporations, firms, or individuals and to do every other act or thing incidental or appurtenant to or growing out of or connected with the aforesaid business, or any part thereof, provided the same is not inconsistent with the Alabama Business Corporation Act.
