Know All Men by These Presents: That in consideration of **Three hundred eighty five thousand and no/100 (\$385,000.00)** to the undersigned grantor, a corporation, in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Heatherbrooke Construction Company, Inc.** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Kevin B.
