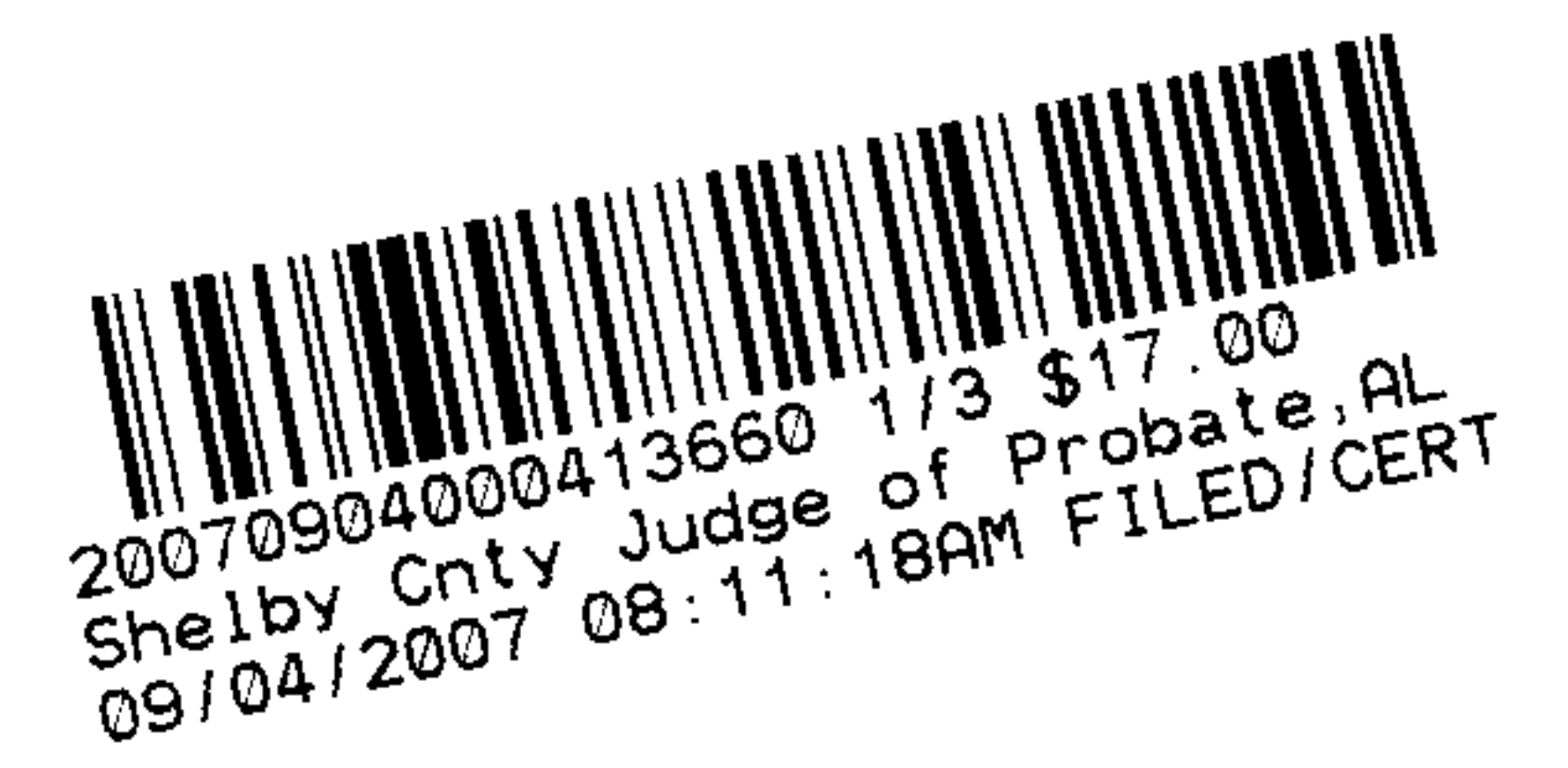
**FURTHER RESOLVED**, that the undersigned Members warrant that the conveyance transaction is in compliance with the Articles of Organization and Operating Agreement.




