**CORPORATION FORM WARRANTY DEED, JOINTLY FOR LIFE WITH  
REMAINDER TO SURVIVOR**

That in consideration of **Two Hundred Seventy Eight Thousand and 00/100 Dollars (\$278,000.00)**, to the undersigned Grantor, **Big Sky Builders, Inc.**, a corporation, (herein referred to as Grantor), in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, the said Grantor does by these presents, grant, bargain, sell and convey unto **Michael Allen Williams and Christine C. Williams**, herein referred to as grantees, as joint tenants, with right of survivorship, the following described real estate, situated in **Shelby County, Alabama**, to-wit:

**Lot 21, according to the Survey of Bent Creek Subdivision-Sector 1, as recorded in Map Book 36, Page 23, in the Probate Office of Shelby County, Alabama.**
