POWER OF ATTORNEY

ONE HUNDRED THOUSAND (\$100,000.00) DOLLARS

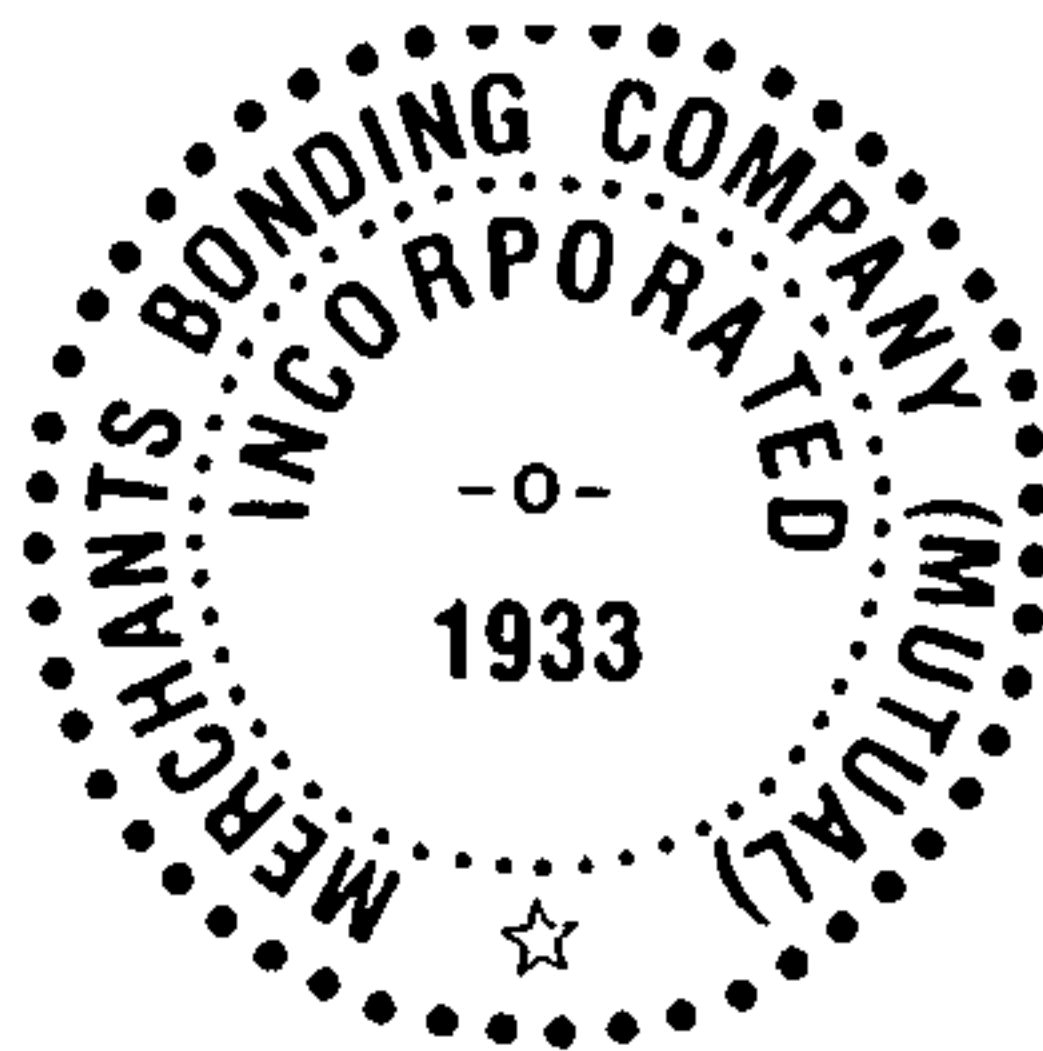

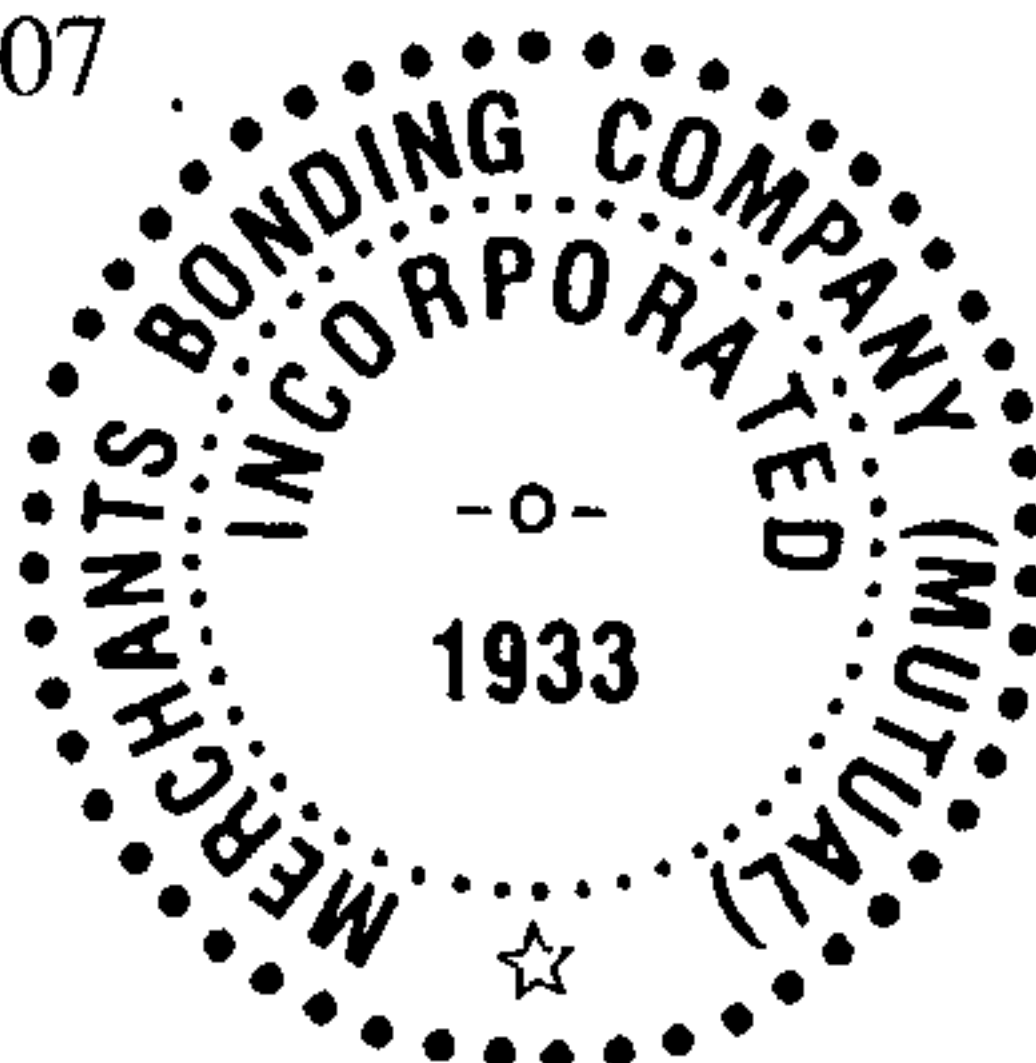
