Know All Men by These Presents: That in consideration of **One hundred eighty seven thousand five hundred and no/100 (\$187,500.00)** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Janet S. Subject to mineral and mining rights if not owned by Grantor.

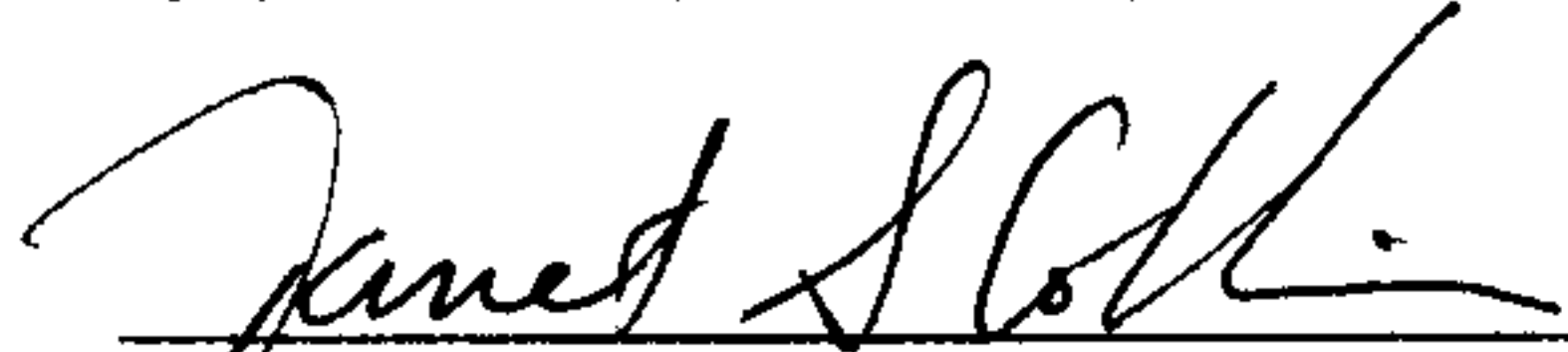
Subject to existing easements, restrictions, set-back lines, rights of way, limitations, if any of record.

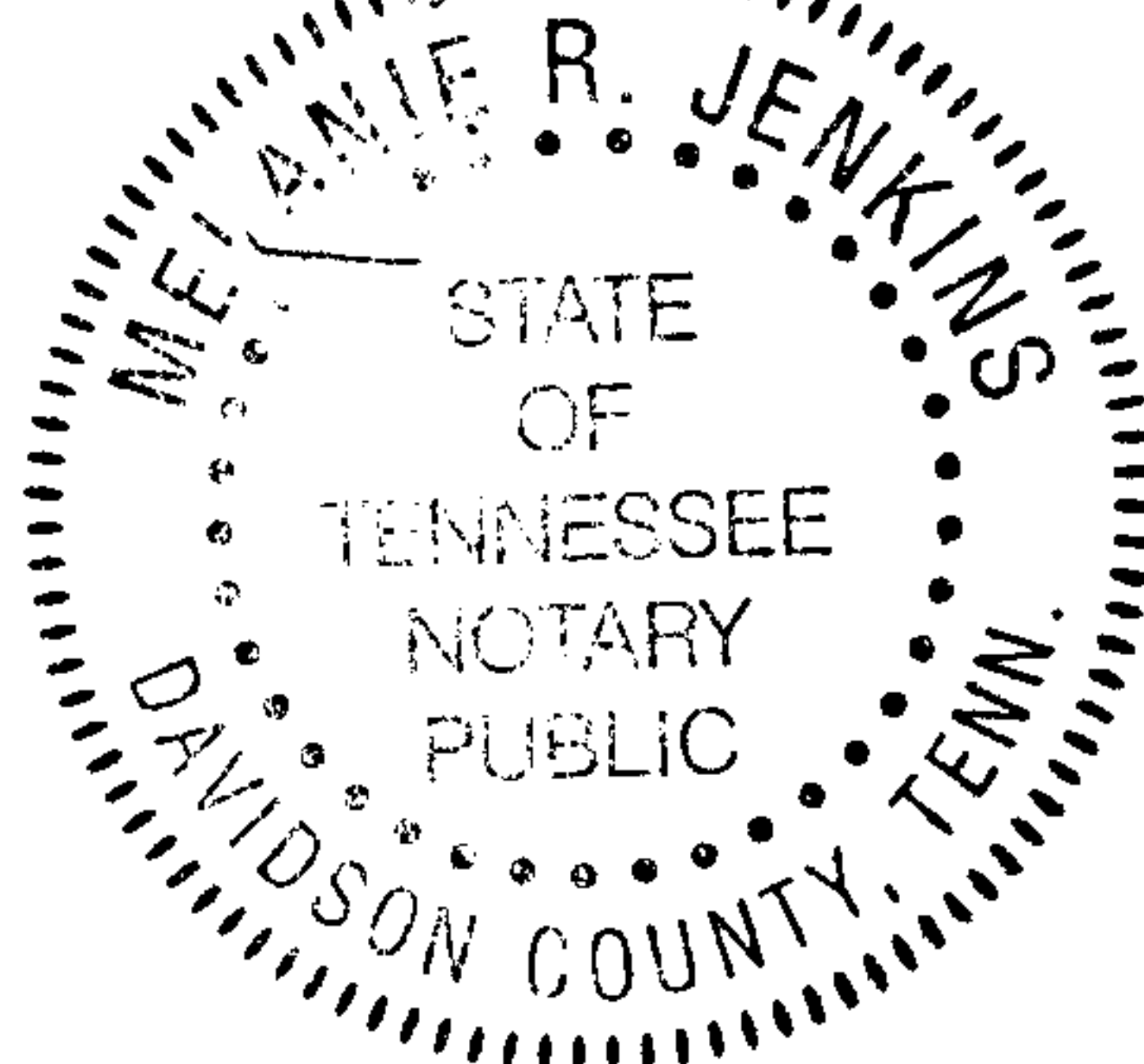

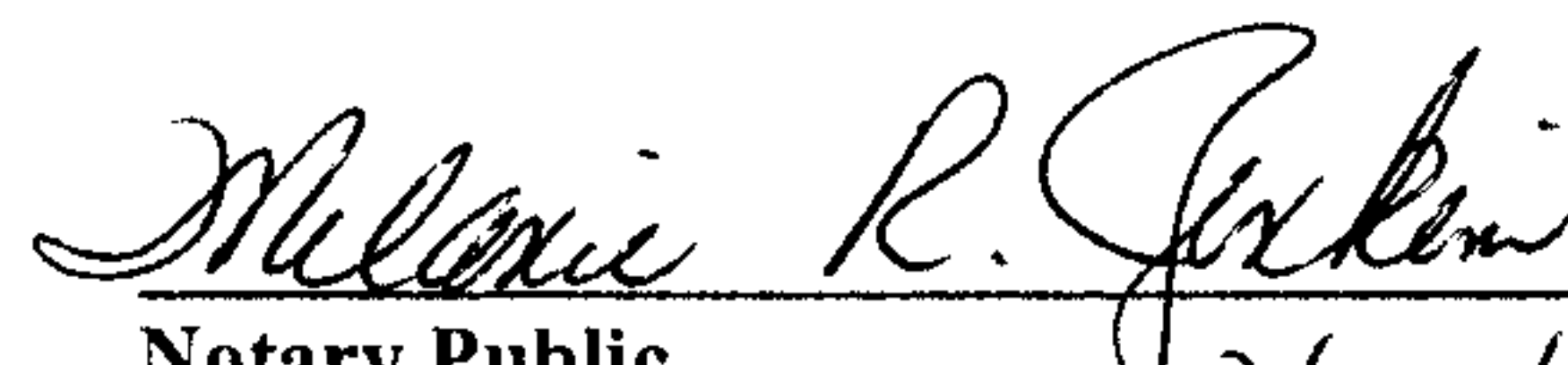
