POWER OF ATTORNEY

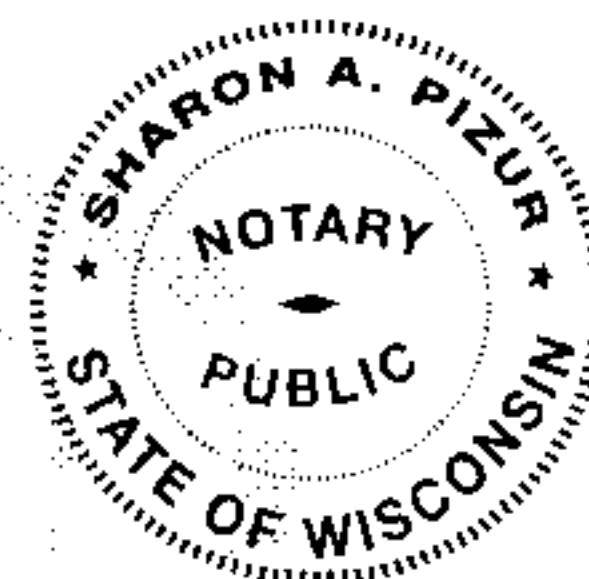
