ORDINANCE NO.

WHEREAS, on the 7th day of August, 2007, James Neil Hughes & George Elwin Hughes filed a petition with the Town of Westover, Alabama, as required by §§ 11-42-20 and 11-42-21, Code of Alabama 1975, as amended, petitioning and requesting that the property hereinafter described be annexed to the municipality of the Town of Westover, Alabama, which petition contained an accurate description of the property proposed to be annexed together with a map of the said property showing its relationship to the corporate limits of the Town of Westover, Alabama, and the signatures of the owners of the property described were signed thereto;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF WESTOVER, ALABAMA, AS FOLLOWS:

1. That the Town of Westover, Alabama, does adopt this Ordinance assenting to the annexation of the following described property to the municipality of the Town of Westover:

Commencing at a 1" pipe found at the NE corner of Section 30, Township 19 South, Range 1 East, Shelby County, Alabama, thence S 1° 8' 50" W a distance of 825.26 feet to a capped rebar set; thence S 67° 06' 37" W a distance of 234.42 feet to the point of beginning on the Westover Town limits; thence continue S 67° 8' 50" W a distance of 39.01 feet; thence N 1° 10' 23" E a distance of 937.90 feet to a point; thence S 88° 33' 45" E a distance of 35.62 feet to a point on the Westover Town limits; thence S 1° 10' 23" W along the Westover Town limits a distance of 921.83 feet to the point of BEGINNING.

2. That the corporate limits of the Town of Westover, Alabama, be extended and rearranged so as to embrace and include such property, and such property shall become a part of the corporate area of such municipality upon the date of publication or posting of this Ordinance, as provided for in the Code of Alabama as cited above.

3. That the Town Clerk be and he is hereby authorized and directed to file a copy of this Ordinance, including an accurate description of the property being annexed, together with a map of the said property showing its relationship to the corporate limits of the Town of Westover, Alabama, to which said property is being annexed, in the office of the Judge of Probate of Shelby County, Alabama.

4. That the Zoning Map of the Town of Westover, Alabama, and any other official maps or

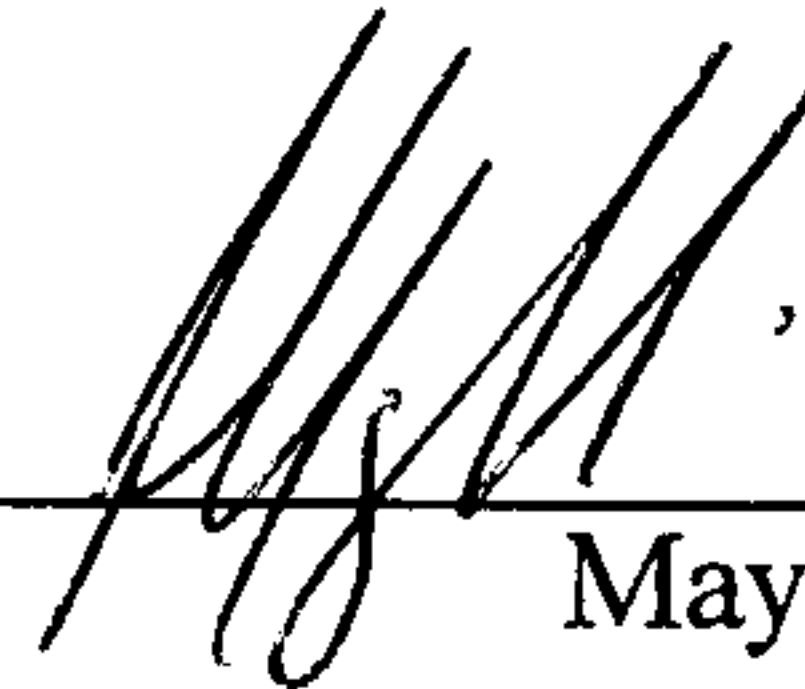
surveys of the Town shall be amended to reflect the annexation of the above-described property, and that a copy of this Ordinance be transmitted to the Town Planning Commission.

5. That this property is zoned AP as provided in the Zoning Ordinance of the Town of Westover, Alabama.

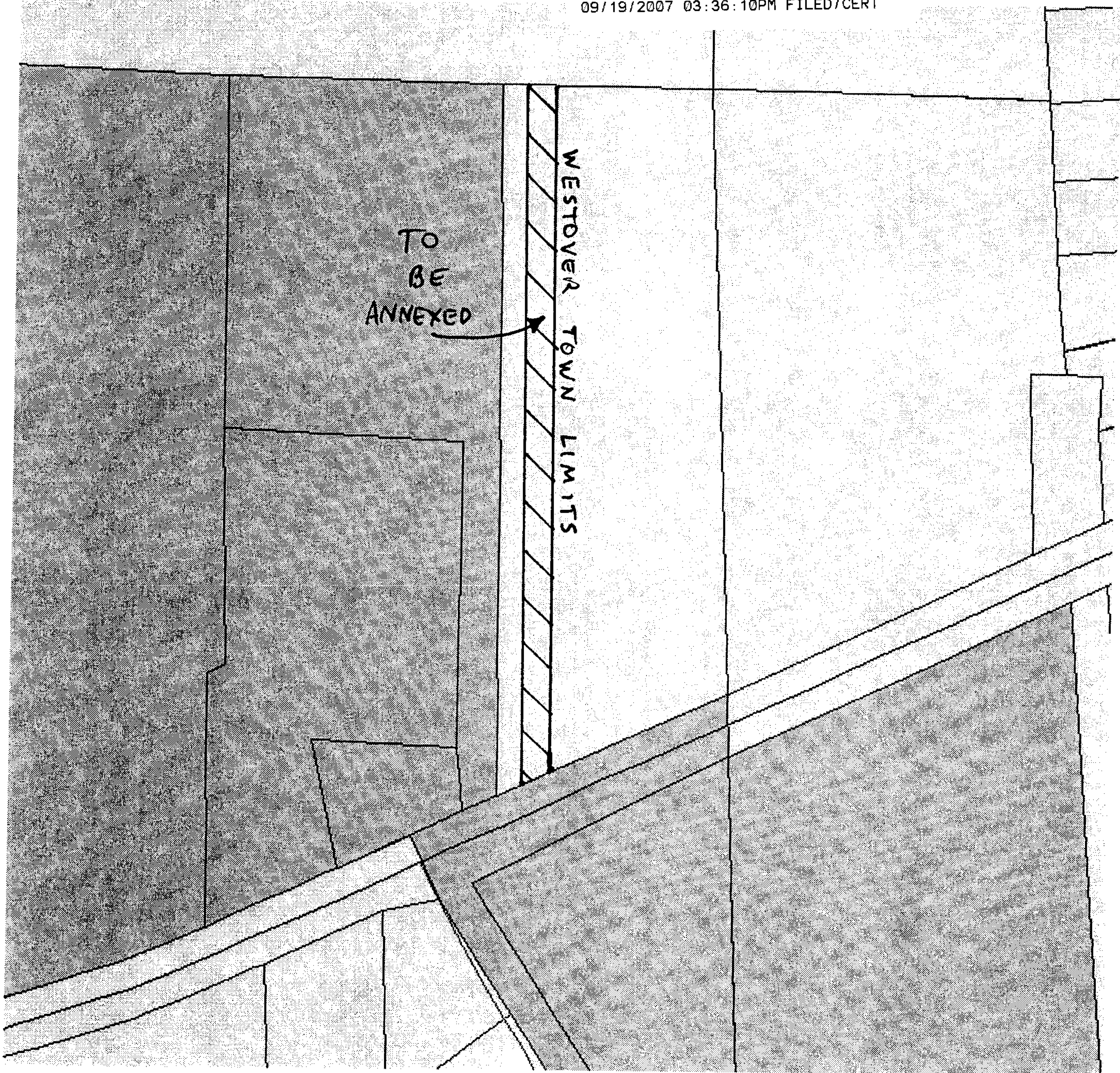
