WHEREAS, heretofore, on, to-wit: the 25th day of August 1999, Clifford H. 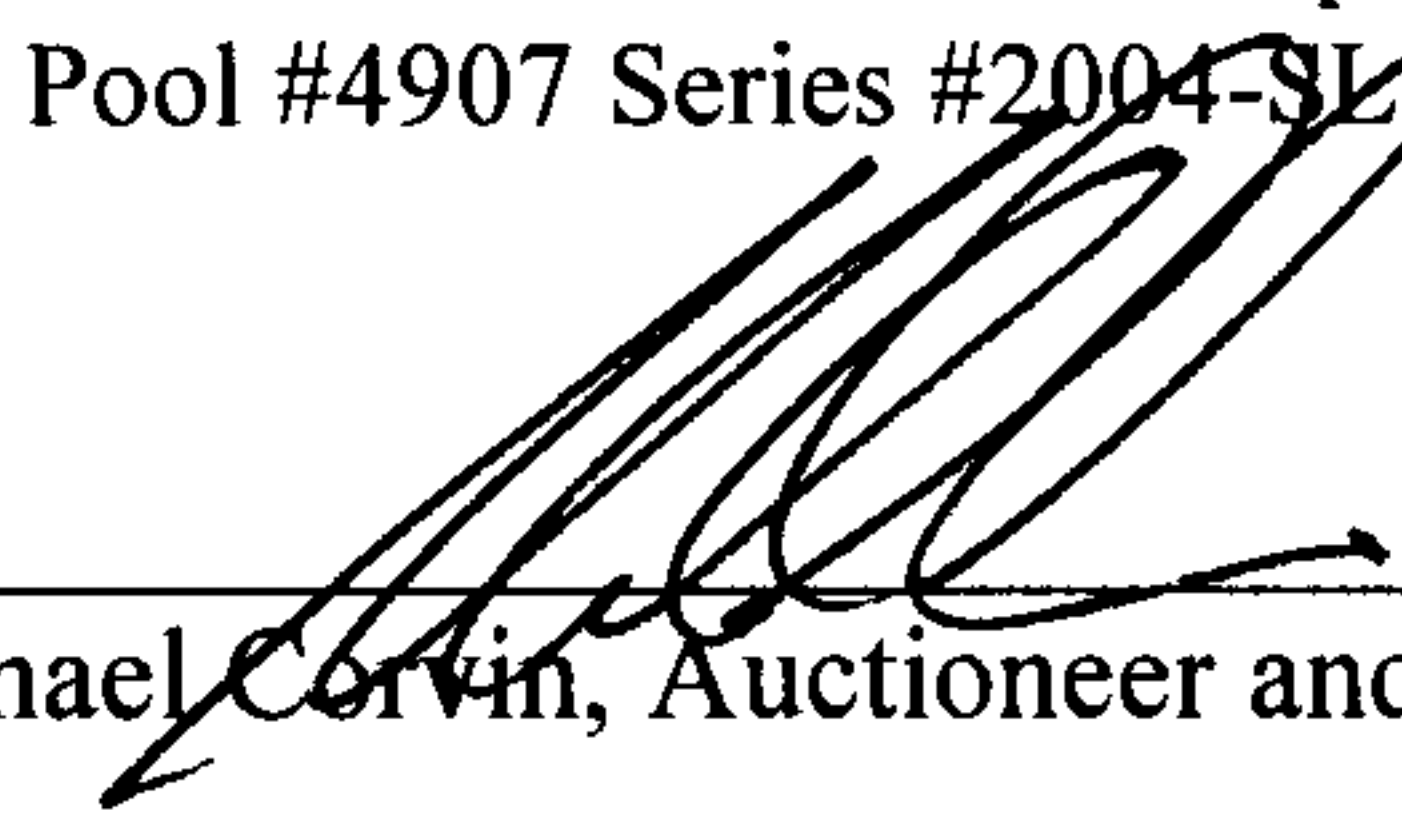

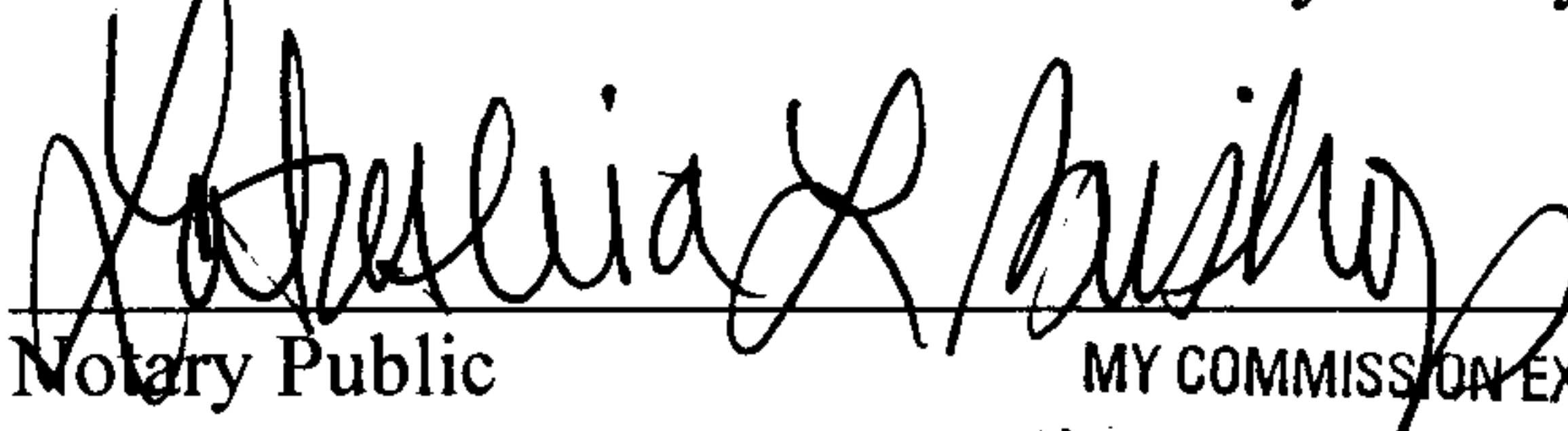
