KNOW ALL MEN BY THESE PRESENTS, That,

WHEREAS, on October 10, 2001, Tyhease Cheyvonne Daniels, a single woman executed a certain mortgage to Shelby County Habitat for Humanity, Inc., said mortgage being recorded in Instrument No. 2001-45220 and corrected in Instrument No. 2002-41507 and being last transferred to Shelby County Habitat for Humanity, Inc. on May 24, 2007 under Instrument No. 20070524000242210 n the Probate Office of Shelby County, Alabama; and

S. WHEREAS, on September 20, 2007, the day on which the foreclosure sale was due to be held under the terms of said notice between the legal hours of sale, said foreclosure sale was duly and properly conducted, and the said Greater Birmingham Habitat for Humanity, Inc. by successor in merger with Shelby County Habitat for Humanity, Inc. on May 25, 2006, as transferee, did offer for sale and sell at public outcry at the main entrance of the Courthouse, Columbiana, Shelby County, Alabama, the property hereinafter described; and

WHEREAS, the highest and best bid obtained for the property described in the aforementioned mortgage was the bid of the said Greater Birmingham Habitat for Humanity, Inc., as transferee, in the amount of Sixty Five Thousand One Hundred Seventy Eight and 33/100 Dollars (\$65,178.33) which sum was offered to be credited on the indebtedness secured by said mortgage, and said property was thereupon sold to the said Greater Birmingham Habitat for Humanity, Inc.; and

WHEREAS, Lorrie Maples Parker, Attorney at Law, on behalf of Greater Birmingham Habitat for Humanity, Inc., as Mortgagee, conducted said sale on behalf of the said Greater Birmingham Habitat for Humanity, Inc.; and

WHEREAS, said mortgage expressly authorized the person conducting said sale to execute to the purchaser at said sale a deed to the property so purchased.

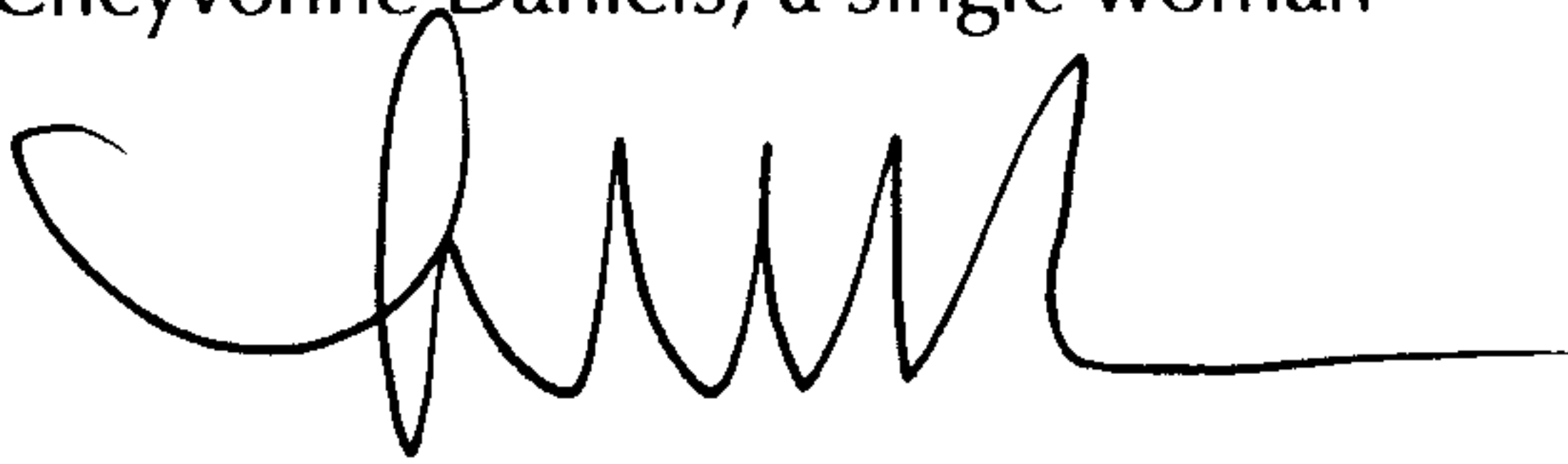

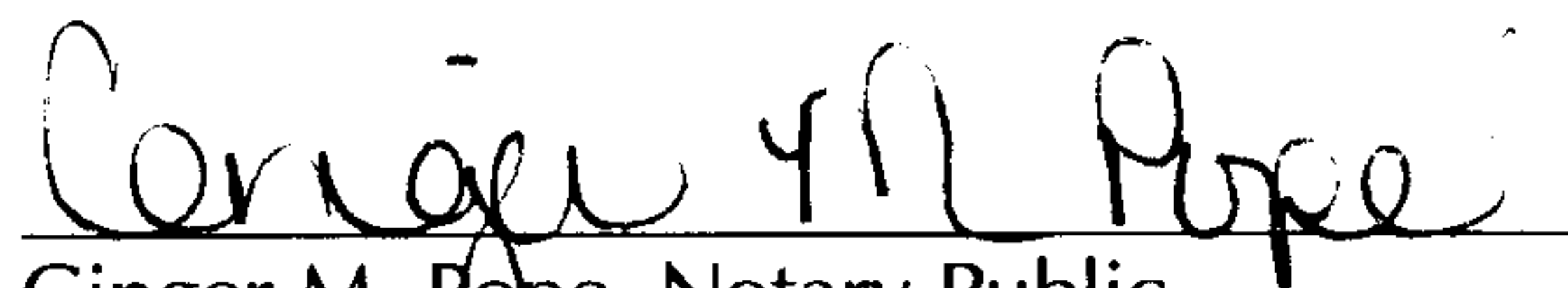
