KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 5th day of April, 2006, Mary Blackburn, who took title as Mary McWilliams Blackburn, executed that certain mortgage on real property hereinafter described to CitiBank, Federal Savings Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20060501000202000, said mortgage having subsequently been transferred and assigned to CitiMortgage, Inc., and

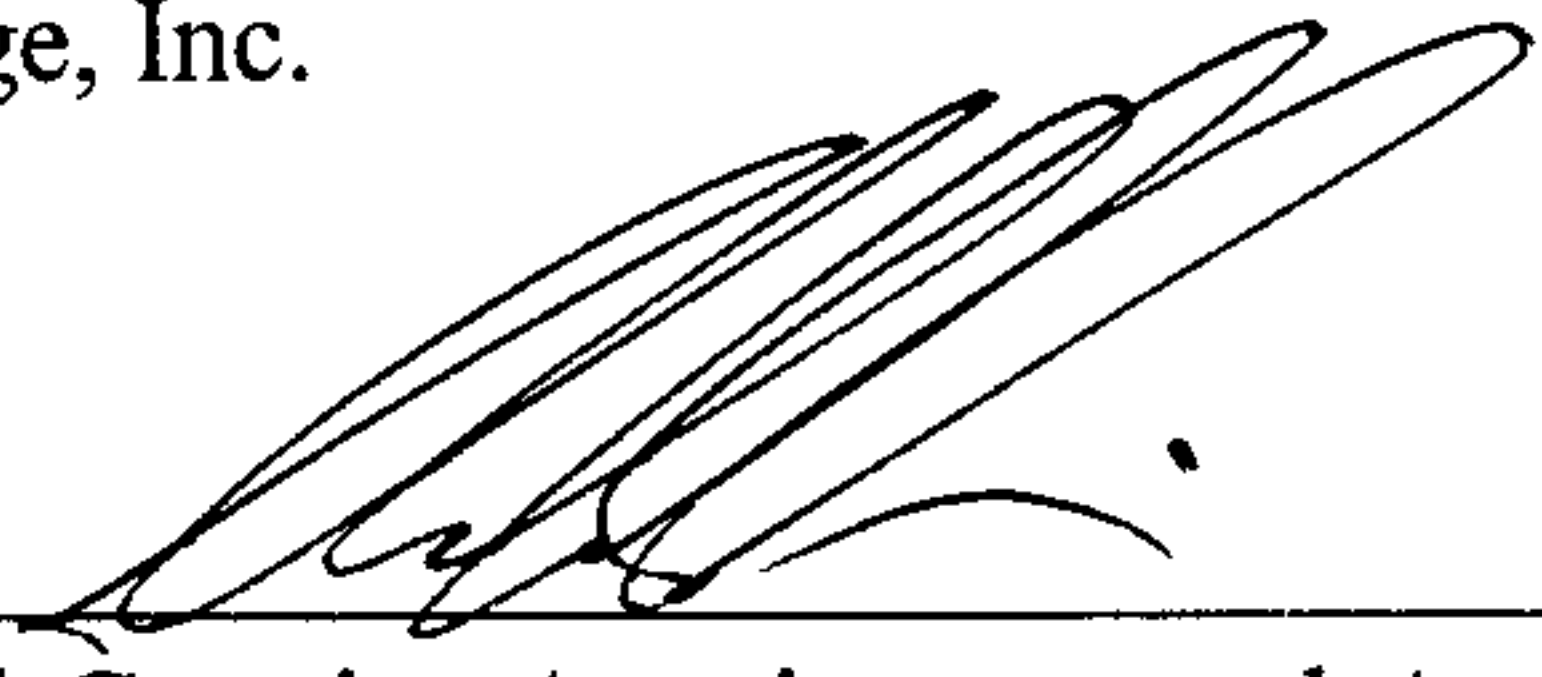

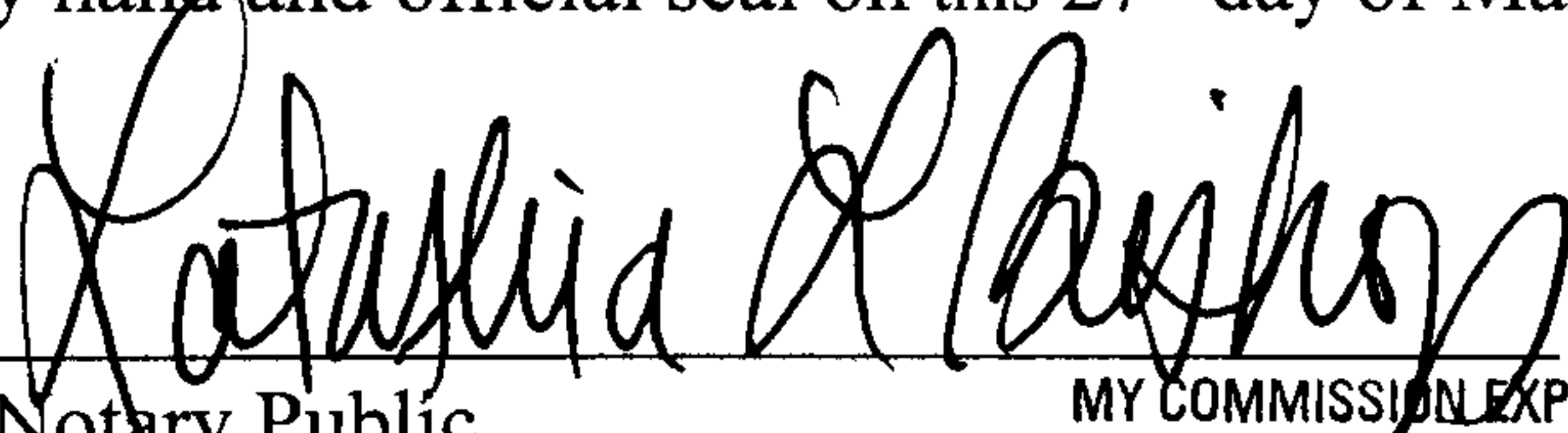
