Warranty Deed
Jointly for Life with Remainder to Survivor

Know All Men by These Presents: That in consideration of *Five Hundred Dollars (\$500.00)* to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **William Timothy Reed and Lynn A. Hall Reed, husband and wife** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Ricky J. Cloutier and Marna D. Cloutier** (herein referred to as grantee, whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:

Lot 2, according to the Preliminary Plat of Cloutier Subdivision, as recorded in Map Book 39, Page 32, in the Office of the Judge of Probate of Shelby County, Alabama.

Subject to all easements, restrictions, reservations, provisions, covenants, building set-back lines and rights of way of record.

To Have and to Hold to the said grantees for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, and to the heir or assigns of such survivor forever, together with every contingent remainder and right of reversion.
