KNOW ALL MEN BY THESE PRESENTS, that in consideration of Fifty Eight Thousand Two Hundred Twenty Five and NO/100 (\$58,225.00) Dollars and other good and valuable consideration to the undersigned, Henry T. Holifield, a married man herein referred to as Grantor, in hand paid by Vincent Farms, LLC referred to as Grantee, the receipt of which is acknowledged, the said Grantor does hereby grant, bargain, sell and convey unto the Grantee, the following described real estate, situated in Shelby County, Alabama, to-wit:
