### FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 30th day of August 2006, Christopher Bunch, unmarried, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. as nominee for Wilmington Finance, Inc. , which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20060907000440650, said mortgage having subsequently been transferred and assigned to U.S. Bank, National Association as Trustee for the MLMI SURF Trust Series 2006-BC5, and

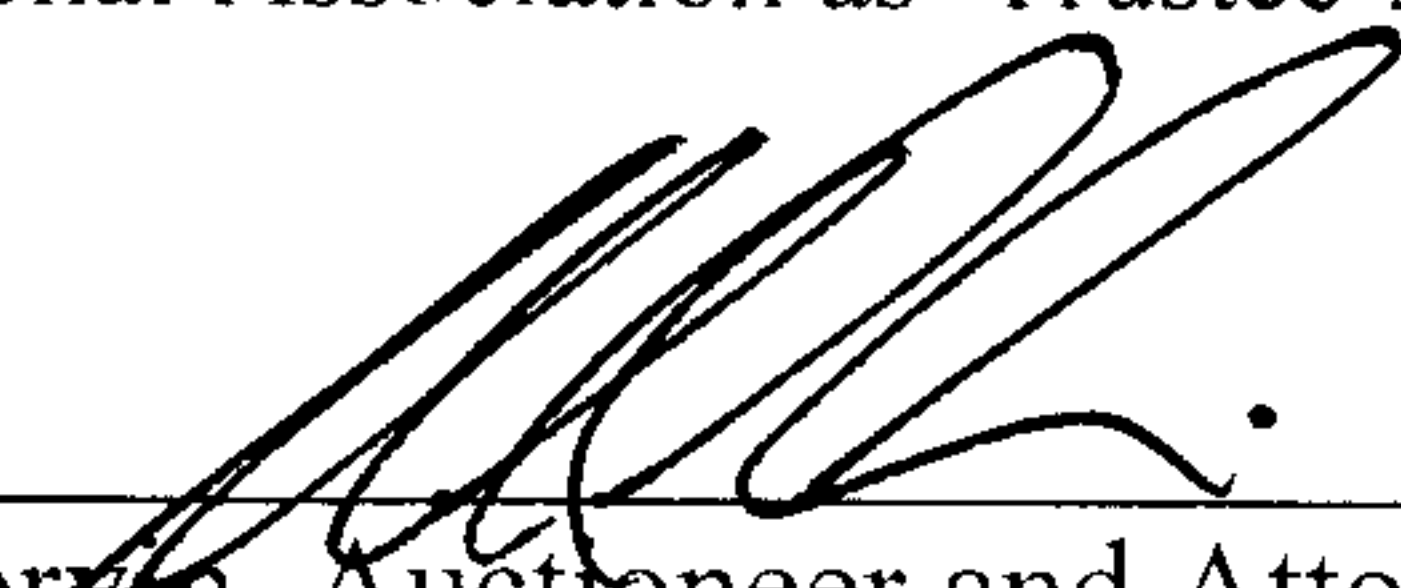

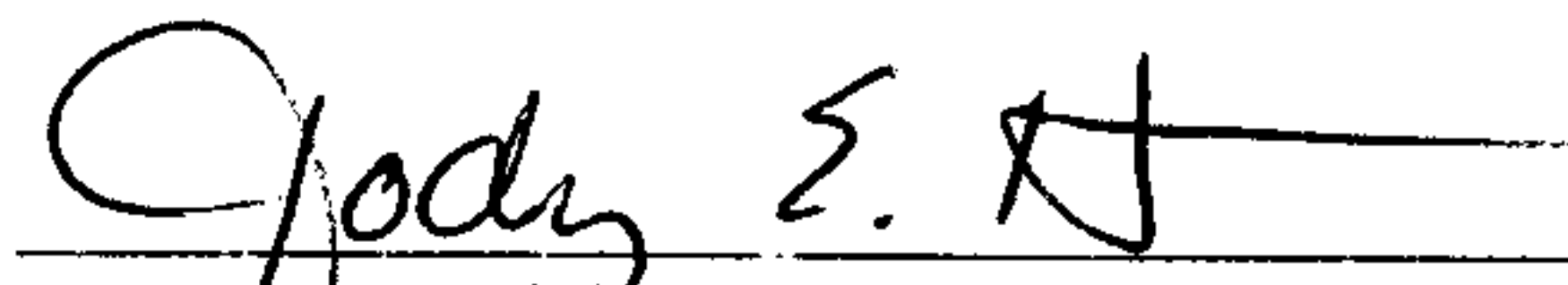
