KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 21st day of June 2004, Virgil Trammell III and Robin Patton Trammell, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for Homestead Financial, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20040706000370440, said mortgage having subsequently been transferred and assigned to CitiMortgage, Inc.; and recorded in Instrument No. 20070730000352180


