

STATUTORY WARRANTY DEED


KNOW ALL MEN BY THESE PRESENTS:

That in consideration of Ten Dollars (\$10.00) and other good and valuable considerations, in hand paid to C&A ENTERPRISES, L.L.C., an Alabama limited liability company, AWTREY INVESTMENT REALTY, LLC, an Alabama limited liability company, and COLE INVESTMENT REALTY, LLC, an Alabama limited liability company ("Grantors") by SHARP PELHAM, LLC, an Alabama limited liability company ("Grantee"), the receipt and sufficiency of which are hereby acknowledged, Grantors do hereby grant, bargain, sell, and convey unto Grantee an undivided twenty-two percent (22%) interest in and to the real estate (the "Property") situated in Shelby County, Alabama, more particularly described as follows, to-wit:



PARCEL 5:

Commence at the Southwest corner of the Southwest one-quarter of the Southwest one-quarter of said Section; thence run South 89 degrees 58 minutes 11 seconds East for a distance of 586.36 feet to the POINT OF BEGINNING and the point of commencement of a curve to the right, said curve having a radius of 780.00 feet, a central angle of 24 degrees 55 minutes 21 seconds, a chord bearing of North 19 degrees 39 minutes 24 seconds East for a chord distance of 336.62 feet; thence run along arc of said curve for a distance of 339.28 feet to the point of commencement of a reverse curve to the left, said curve having a radius of 270.00 feet, a central angle of 32 degrees 33 minutes 53 seconds, a chord bearing of North 15 degrees 50 minutes 08 seconds East for a chord distance of 151.40 feet; thence run along arc of said curve for a distance of 153.46 feet; thence run North 00 degrees 26 minutes 49 seconds West for a distance of 125.24 feet; thence run North 89 degrees 45 minutes 50 seconds East for a distance of 90.46 feet; thence run North 89 degrees 45 minutes 50 seconds East for a distance of 515.68





TO HAVE AND TO HOLD unto Grantee, its successors and assigns forever; subject, however, to the following matters:


