

# ARTICLES OF ORGANIZAITON OF Barr and Associates, LLC

The undersigned organizer, for the purpose of forming a limited liability company under Title 10, Chapter 12 of the <u>Code of Alabama</u> (1975), as amended (the "Alabama Limited Liability Company Act"), hereby files the following Articles of Organization with the probate judge of the County in which the initial registered office of the limited liability company will be located and attests that the facts stated in these Articles of Organization are true and correct:

## ARTICLE I NAME

The name of this limited liability company (the "Company") shall be: Barr and Associates, LLC.

#### ARTICLE II DURATION


The period of duration is perpetual unless the Company shall be sooner dissolved and its affairs wound up in accordance with its Articles of Organization or Operating Agreement.

### ARTICLE III PURPOSES

The nature of the business of the Company and its objects, purposes and powers are as follows:

- (b) In general, to carry on any other lawful business whatsoever in connection with the foregoing or which is calculated, directly or indirectly, to promote the interest of the Company or to enhance the value of its properties.

not be deemed to exclude or in any way limit by inference any powers, objects or purposes which the Company is empowered to exercise, whether expressly by purpose or by any of the laws of the State of Alabama or any reasonable construction of such laws.

### ARTICLE IV REGISTERED AGENT/ OFFICE

The location and mailing address of the initial registered office of the Company shall be 5451 South Shadescrest Road, Birmingham, Alabama 35022, and its registered agent at such address shall be Dena Barr.

### ARTICLE V INITIAL MEMBERS
