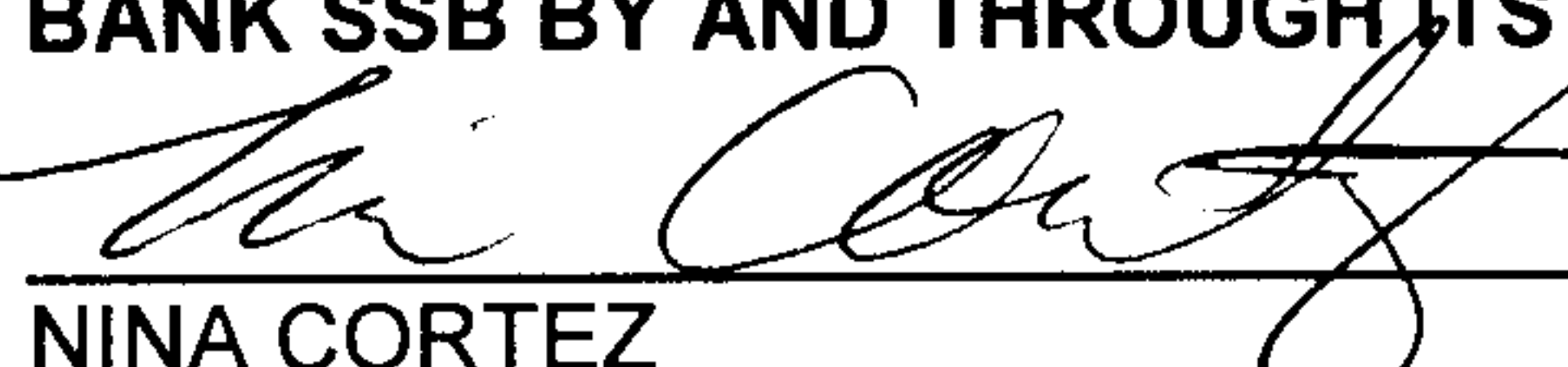
Whereas, the indebtedness secured by said mortgage has been paid in full,

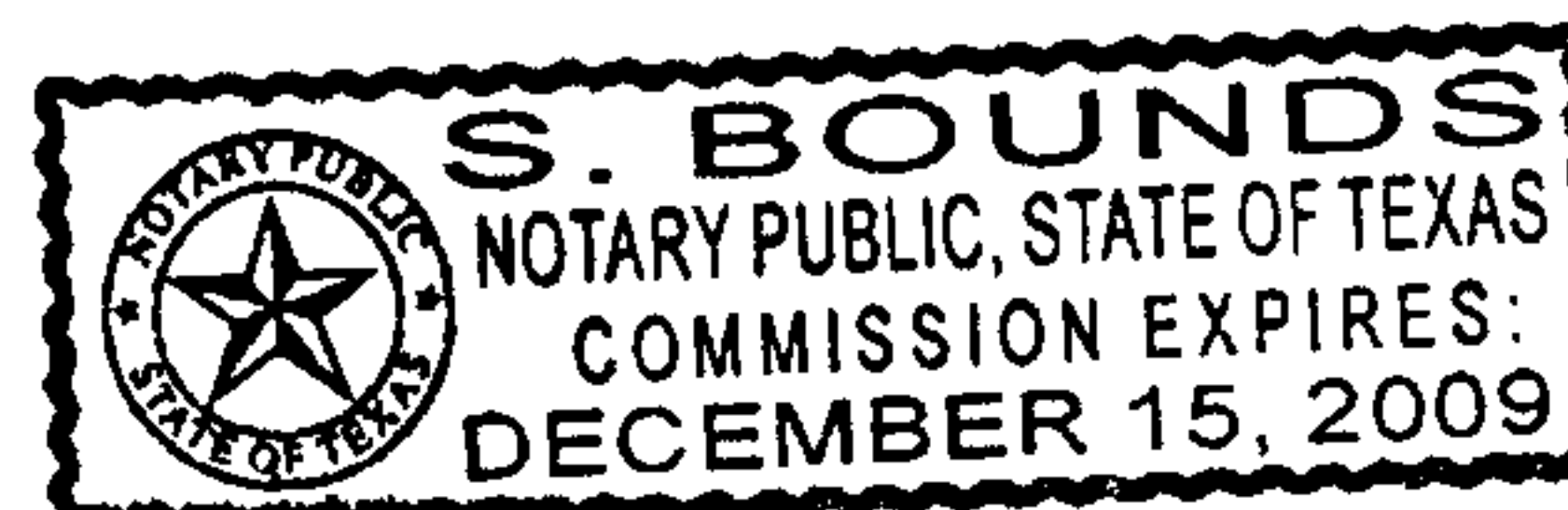
