

## EXHIBIT "A" LEGAL DESCRIPTION

A parcel of land in the NE ¼ of the NE ¼, Section 30, Township 22 South, Range 3 West, Shelby County, Alabama, described as follows: From the NE corner of said ¼-1/4 section, run West along the North ¼-1/4 line for 814.65 feet; thence deflect left 85 degrees and 45 minutes and run southerly for 21.8 feet to a point on the South R.O.W. line of County Road No. 204 and the point of beginning of subject parcel of land from said point, thus established, continue to run said course for 634.9 feet to a point on a fence; thence deflect right 85 degrees and 45 minutes and run westerly along said fence for 163.35 feet; thence deflect right 94 degrees 15 minutes and run northerly and parallel to the East lot line for 634.9 feet to a point on said road R.O.W. line; thence deflect right 85 degrees 45 minutes and run easterly along said road right of way line for 163.35 feet and back to the point of beginning; being situated in Shelby County, Alabama.
