KNOW ALL PERSONS BY THESE PRESENTS: That Edwin L. Edwards and Ann G. Edwards, Husband and Wife, did, on to-wit, October 4th, 2002, execute a mortgage to AmSouth Bank, now Regions Bank Successor by Merger to AmSouth Bank, which mortgage is recorded in Instrument No. 20021021000516290, et seq., in the Office of the Judge of Probate of SHELBY County, Alabama; and

WHEREAS, the highest and best bid for cash obtained for the property described in the aforementioned mortgage was the bid of the said Regions Bank Successor by Merger to AmSouth Bank in the amount of ONE MILLION ONE HUNDRED SIXTEEN THOUSAND and 00/100ths (\$1,116,000.00) DOLLARS, which sum the said Regions Bank Successor by Merger to AmSouth Bank offered to credit on the indebtedness secured by said mortgage, and said property was thereupon sold to the said Regions Bank Successor by Merger to AmSouth Bank; and
