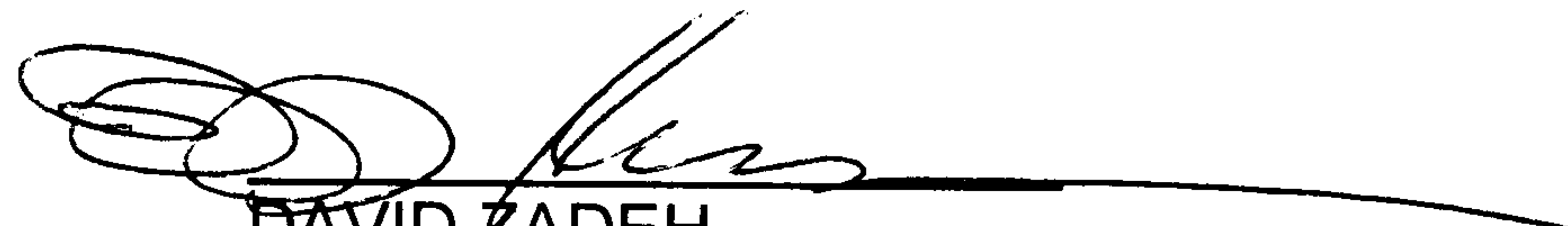
FULL RELEASE AND SATISFACTION OF MORTGAGE

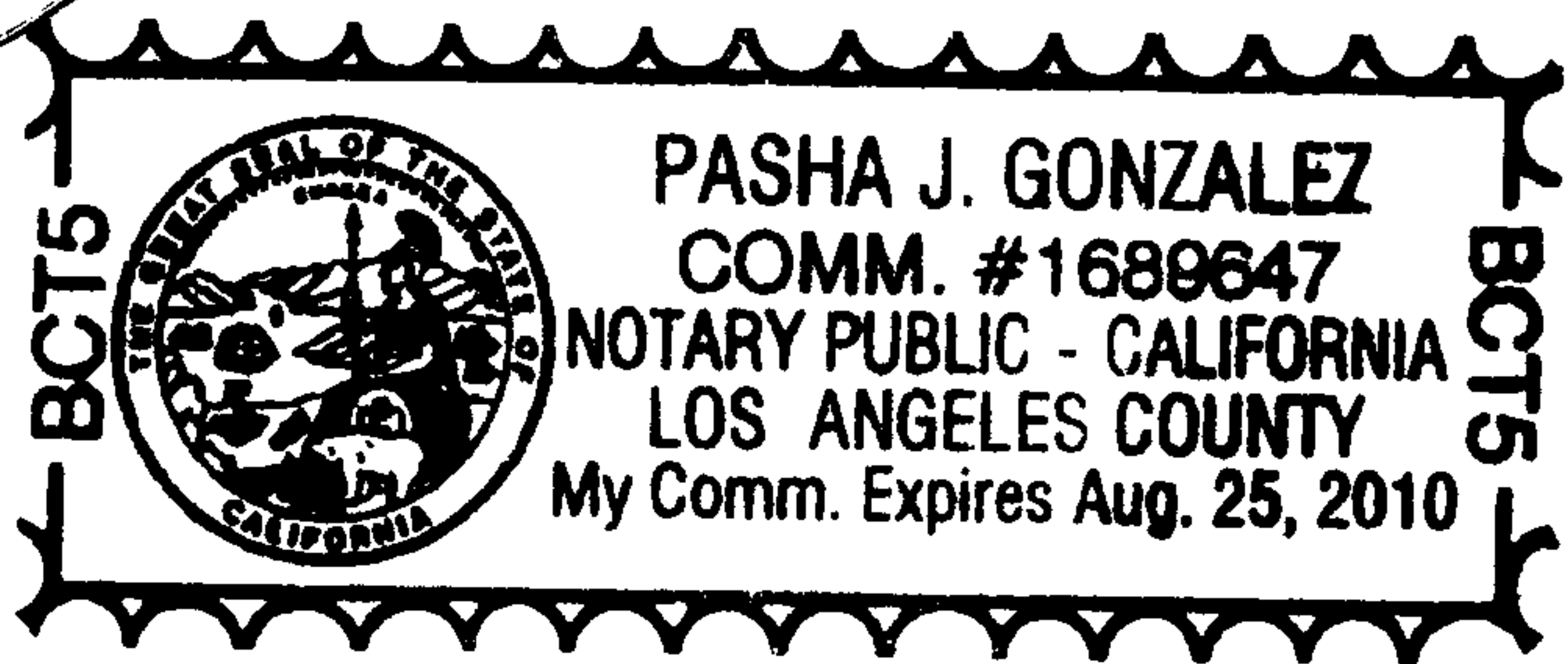
