



## LOAN MODIFICATION AGREEMENT

This agreement is by and between Regions Bank ("Bank") and Cena Homes, Inc.("Borrower").

WHEREAS, Borrower is indebted to Bank on a ("Loan"), as evidenced by a Promissory Note and Mortgage, dated March 27, 2007, said mortgage recorded in Instrument #20070330000144280, in the Probate Office of Shelby County, Alabama.

This additional \$375,000.00 shall be disbursed by the "Bank" as additional funds are required by the "Borrower". If all funds are not required, the balance shall be applied to the note referenced herein. All other terms, conditions and collateral of the note herein referenced shall be made a part of this modification agreement and control the repayment terms thereof.

Except as modified herein, all of the terms and conditions of the Loan, the Note and Mortgage and any and all other instruments executed in connection with said Loan shall remain in full force and effect.
