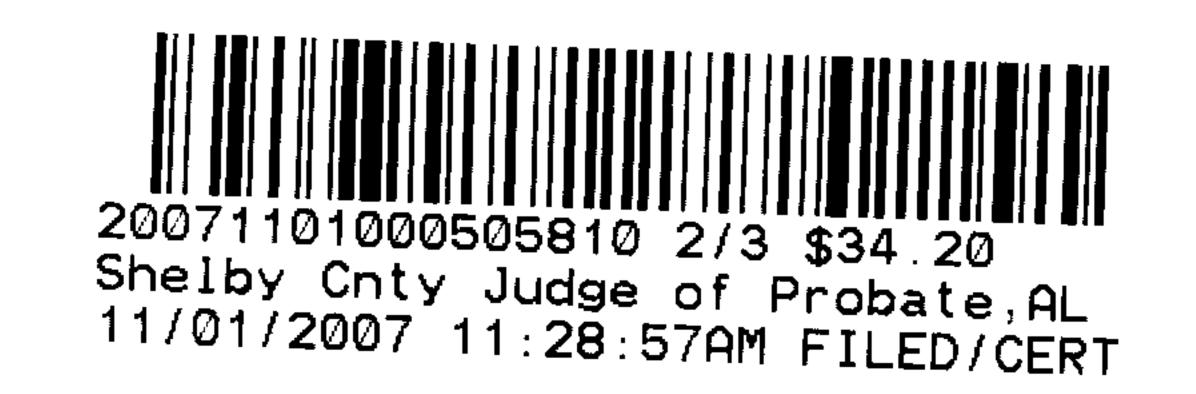

## WARRANTY DEED

STATE OF ALABAMA COUNTY OF SHELBY

KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of Two Hundred Two Thousand Nine Hundred and No/100 Dollars (\$202,900.00) to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged, UNITED HOMEBUILDERS, INC., (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto STEVEN L. ROMINE and SHELBY J. ROMINE, (herein referred to as "Grantee"), as joint tenants with rights of survivorship, the following described real estate situated in Shelby County, Alabama, to wit:

Lot 325, according to the Survey of Forest Parks, 3rd Sector, as recorded in Map Book 22, page 151, in the Probate Office of Shelby County, Alabama.

Subject to all easements, restrictions, covenants, rights of way and covenants of record; taxes for 1998 and subsequent years not yet due and payable.

\$162,320.00 of the purchase price recited herein was paid from the proceeds of two mortgage loans closed simultaneously herewith.
