WARRANTY DEED AND LIMITED POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS: That in consideration of
(\$ 225,000.00) to the undersigned Grantors in hand paid by the Grantees, whether one or
more, herein, the receipt of which is hereby acknowledged, we, KYLE R. STOPA and LINDSEY M.
STOPA, husband & wife, (herein referred to as Grantors) do grant, bargain, sell and convey unto
Ronald Keel and Claudine Keel (herein referred
to as Grantees) as individual owner or as joint tenants, with right of survivorship, if more than one,
the following described real estate, situated in the State of Alabama, County of Shelby, to-wit:

**This conveyance is hereby made subject to restrictions, easements and rights of

\$ 115,000.00 of the purchase price recited above was paid from a mortgage loan closed
simultaneously herewith.

TO HAVE AND TO HOLD unto the said Grantee(s), his/her/their heirs and assigns, forever;
it being the intention of the parties to this conveyance, that if more than one Grantee, then to the
Grantees as joint tenants with right of survivorship (unless the joint tenancy hereby created is severed
or terminated during the joint lives of the Grantee(s) herein) in the event one Grantee herein survives
the other, the entire interest in fee simple shall pass to the surviving Grantee and if one does not
survive the other, then the heirs and assigns of the Grantees herein shall take as tenants in common.

Grantee(s), his/her/their heirs and assigns, that we are lawfully seized in fee simple of said premises;
that they are free from all encumbrances, unless otherwise noted above; that we have a good right to

warrant and defend the same to the said Grantee(s), his/her/their heirs, and assigns forever, against
the lawful claims of all persons.


do by these presents make, constitute and appoint Cartus Financial Corporation, a Delaware

This power of attorney is coupled with an interest and shall remain in force and effect until delivery of this deed and the sale closed, and shall not be revoked by either of the undersigned prior to said time.




