Know All Men by These Presents: That in consideration of **Two hundred twenty nine thousand nine hundred and no/100 (\$229,900.00)** to the undersigned grantor, a corporation, in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Don Martin Construction Company, Inc.** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Richard E. Rhoades and Elizabeth Ames Rhoades** (herein referred to as grantee, as joint tenants of survivorship whether one or more), the following described real estate, situated in **Shelby** County, Alabama, to-wit:

Lot 1627, according to the Final Plat Strathaven at Ballantrae, Phase I, as recorded in Map Book 37, Page 128, in the Probate Office of Shelby County, Alabama.
