KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of **Two Hundred Twenty Five Thousand dollars and Zero cents (\$225,000.00)** paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, **Scott E. Seay and Keisha S. Seay, husband and wife** (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto **Ellison M. Clark and Doris J.
