**VERIFIED CLAIM OF LIEN**

Five Star Lumber, Inc., a Corporation qualified under the laws of the State of Alabama, by and through Bradley H. Byers who has personal knowledge of the facts herein set forth, files this statement in writing, verified by his oath. Five Star Lumber, Inc., claims a lien upon certain real property located at Lot 19, Parkside Village, Pelham, Alabama and Lot 3, Nottingham, Pelham, Alabama and situated in Shelby County, Alabama, more particularly described as follows, to-wit:

- (1) LOT 19, ACCORDING TO THE FINAL PLAT OF PARKSIDE VILLAGE, PHASE 2, AS RECORDED IN MAP BOOK 37, PAGE 60 IN THE PROBATE OFFICE OF SHELBY COUNTY, ALABAMA.
- (2) LOT 3, ACCORDING TO THE FINAL PLAT NOTTINGHAM, PHASE 2, AS RECORDED IN MAP BOOK 31, AT PAGE 62, IN THE PROBATE OFFICE OF SHELBY COUNTY, ALABAMA.

This lien is claimed, separately and severally, as to the land, buildings and improvements thereon to the extent of the entire lot or parcel which is contained within a city or town. If said land is not within a city or town, this lien is claimed, separately and severally, as to the buildings and improvements located on the above-described real property, plus one (1) acre of land surrounding and contiguous thereto.

This lien is claimed on the above mentioned land, buildings and improvements to secure the indebtedness owed by Brantley Homes, Inc. in the amount of \$17,229.44 for Lot 19, Parkside Village and \$14,875.60 for Lot 3, Nottingham for a total of \$32,105.04, said sum being due and owing after all credits have been given, from the 13th day of June, 2007, and which sum, is presently due and unpaid.
