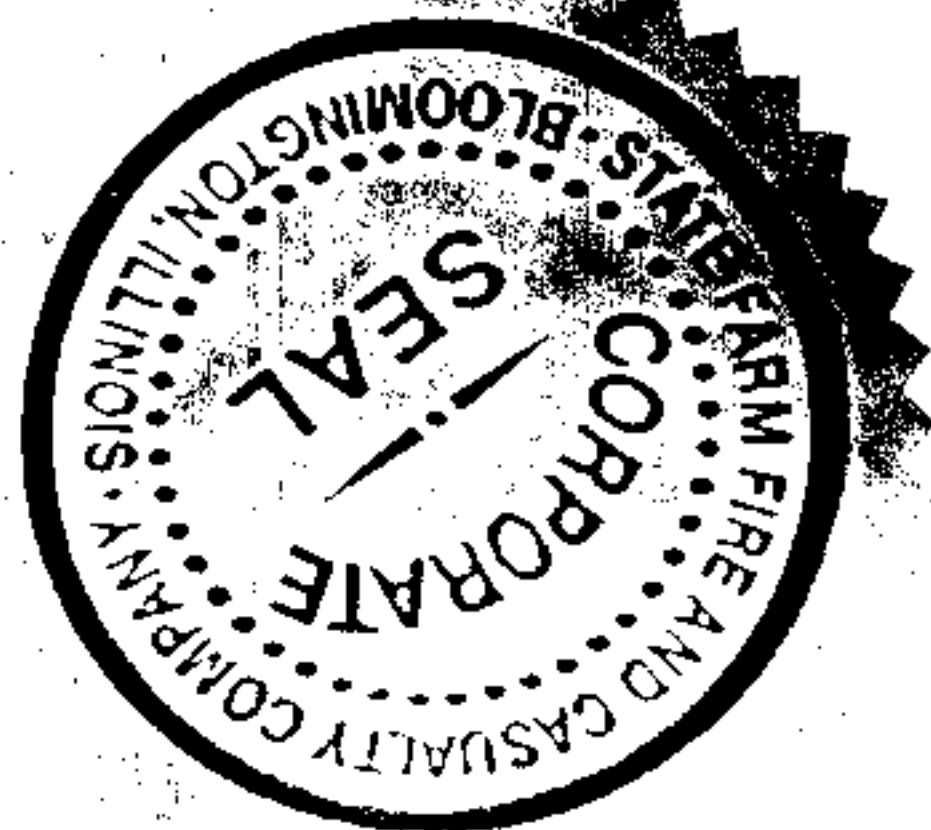
This appointment is made under and by the authority of a resolution which was passed by the Executive Committee of the Board of
