FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 2nd day of January, 1997, Rodney D. Nealey and wife, Elizabeth A. Nealey, executed that certain mortgage on real property hereinafter described to American Home Funding, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 1997-1114; modified by Modification Agreement in Instrument No. 1999-50522, said mortgage having subsequently been transferred and assigned to Norwest Mortgage, Inc., by instrument recorded in Instrument No. 1997-13836, in the aforesaid Probate Office; and




