Know All Men by These Presents: That in consideration of **Two hundred sixty two thousand eight hundred twenty two and no/100 (\$262,822.00)** to the undersigned grantor, a corporation, in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Longleaf Homes, Inc.** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Patrick Lee Mills and Chaney McLendon Mills** (herein referred to as grantee, as joint tenants of survivorship whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:

Subject to mineral and mining rights if not owned by Grantor.


Subject to existing easements, restrictions, set-back lines, right of way, limitations, if any of record.

And I (we) do, for myself (ourselves) and for my (our) heirs, executors and administrators, covenant with said grantee, his, her or their heirs and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise stated above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will, and my (our) heirs, executors and administrators shall warrant and defend the same to the said grantee, his, her or their heirs and assigns forever, against the lawful claims of all persons.
